## Re: Freedom of Information Request FOI-000206-2020 Request Granted

*Dear*

I refer to your request, dated and received on 15<sup>th</sup> June, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

*A breakdown of the costs incurred to run the Garda Air Support Unit in 2017, 2018, 2019 and 2020 to present.*

I wish to inform you that I have decided to **grant** your request on the 17<sup>th</sup> June, 2020.

The purpose of this letter is to explain that decision.

### **1. Findings, particulars and reasons for decision.**

Details of your request were forwarded to the Finance Directorate within An Garda Síochána who conducted a search of their records.
