Re: Freedom of Information Request FOI-000068-2016 Request Refusal

Dear

I refer to the Freedom of Information Act 2014 and your submission to An Garda Síochána, dated 19th February and received on the 22nd February 2016.

Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

Information on all costs (including overtime, the use of Air Support Unit etc) relating to the policing of the funeral mass of David Byrne at the Church of Saint Nicholas of Myra on Francis Street and surrounding areas, the burial at Mount Jerome Cemetery and security arrangements around the family home at Raleigh Square, Crumlin on February 14th and February 15th 2016.

Information on all costs (including overtime, the use of Air Support Unit etc) relating to the policing of the funeral mass of Eddie Hutch at Our Lady of Lourdes Church on Sean McDermott Street and surrounding areas, the burial at Glasnevin Cemetery and any security arrangements around the family home on Poplar Row in Dublin on February 18th and February 19th 2016.

I wish to inform you that your request has been refused.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decisions to deny access

The Financial Management System within An Garda Síochána was queried to identify if the records could be extracted to provide an answer to your request. It has been determined that these specific financial records do not exist.

Members of An Garda Síochána are typically rostered for multiple duties and criminal investigations. The cost of manpower associated with these duties are not analysed nor captured separately on the Financial Management System.

A unique project code does not exist in respect of operational duties referred to in your request. In the absence of such a project code it is not possible to identify the costs.

In accordance with the requirements of Section 15(1)(a) of the Freedom of Information Act 2014, I am satisfied that all reasonable steps have been taken to identify and locate the requested records.

Your request is therefore refused under Section 15(1)(a) of the Act which states:

15. (1) A head to whom an FOI request is made may refuse to grant the request where—

(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

2. Rights of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000068-2016**.

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
