Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated and received on 11th June 2016. You subsequently amended this request on 15th June 2016 and your request has been progressed on that basis.

Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

This is a submission for travel records for personnel travelling to the ISS World, held in Prague in 2015, between 2015-05-25 and 2015-06-12. I'd be interested in records of both Garda and Civilians, per covered by the FOI Act.

I wish to inform you that your request **refused** on 8th July 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions to deny access

Having examined your request I advise that the records sought in relation to travel records for personnel travelling to the ISS World do not relate to "administrative records relating to human resources, or finance or procurement matters" as per Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014. I am therefore refusing these parts of your requests on the basis that they are outside the scope of the Act in so far as it applies to An Garda Síochána.

2. Right of appeal
