Re: Freedom of Information Request FOI-000052-2017 Request Refusal

Dear .

I refer to your request, dated and received on 20th February, 2017 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- Records of the number of children that went missing from State care facilities in 2016. This should include records from all regions in the Republic of Ireland, the west region, southern region and Dublin mid-Leinster region and the northeast Dublin region.
- The age ranges of the children that went missing including the youngest and eldest.
- The nationalities of the missing children.
- The number of children that were returned safely as well as the number of children that have not been found.

I wish to inform you that I have decided to refuse your request on the 22nd February, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

However, some of the information requested by you may be available from Central Statistics Office who receives all crime related data from An Garda Síochána. They can be contacted at Skehard Road, Cork, T12 XOOE, Ireland or alternatively you can email them at crime@cso.ie with your request.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **F01-000052-2017**.
