## Re: Freedom of Information Request FOI-000474-2017 Request Granted

#### Dear

I refer to your request, dated and received on the 25th October 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

In the past three years how much has An Garda received in fees to police events in Donegal?

By events I mean any concerts or sporting events as well as any festivals or parades held by community, voluntary and charity groups in the county.

Can I get this broken down by the name of the event and how much the organisers of each event contributed financially.

I am aware that similar figures for the whole of Ireland were supplied recently to Tánaiste Frances Fitzgerald (http://www.irishexaminer.com/ireland/gardai-received-over-30m-since-2010-to-police-concerts-and-sporting-events-453010.html) and I was looking to get them broken down to Donegal level,

I wish to inform you that I have decided to grant your request on the 20th November, 2017.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Section of An Garda Síochána who have briefed this office on the provisions of non-public duty and have also identified the records for years 2015, 2016 and up to 20<sup>th</sup> November 2017. A copy of these records are outlined below.

Non-public duty is performed by members of An Garda Síochána under arrangements made with organisers of events such as football matches, concerts and race meetings, etc. who seek to engage the services of members of An Garda Síochána to perform duties to which they would not normally be assigned.

Members of An Garda Síochána have been made available for the performance of such duties and the State has charged for their services. This work is normally done by members who would otherwise be off duty. It is generally the practice to charge organisations for the costs of duties performed by members inside the event.

In general, the cost of policing duties performed by Gardaí outside the event such as traffic control, beat patrols and other public policing duties which would be additional to those normally performed at the location, are not paid by the organisation hosting the event but fall to be paid from the Garda Vote. However, at some specific larger events An Garda Síochána seeks a contribution from the promoters to overall policing costs. In this regard, I advise that the level of contribution to be made to An Garda Síochána is agreed by the local District Officer with the organisers, taking into account the nature and size of the event.

At all times it is the policy of An Garda Síochána that the safety of the public must be the ultimate concern.

#### 2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number F0I-000474-2017.
