Dear

I refer to the Freedom of Information Act 2014 and your submission to this body dated 6th January 2016 and received on 7th January 2016.

Part 1 of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is as follows: *"1 Details of any planned Superintendent recruitment/promotion involving lateral transfers or promotions from PSNI*2 Details of any Human Resources plan / strategy
3 Details of the eligibility criteria applied on the last time such a recruitment/promotion"

I have now made a final decision to partially grant your request on 3rd February 2016.

The purpose of this letter is to explain that decision.

Findings, particulars and reasons for decisions to deny access

With regard to the first part of your request seeking, details of any planned Superintendent recruitment/promotion involving lateral transfers or promotions from P.S.N.I., the Chief Constable of the P.S.N.I. is informed when such competitions are being advertised.

The P.S.N.I. was informed on 23rd December 2015 of a competition for promotion to the rank of Superintendent in An Garda Síochána which is open to eligible members of the P.S.N.I. . This competition will be conducted in accordance with An Garda Síochána Guidelines for Internal Appointments and Promotions, and the Code of Practice for Appointments to positions in the Civil Service and Public Service issued by the Commission for Public Service Appointments. This Code of Practice is available from their website <u>http://www.publicjobs.ie/</u>

I advise that I am refusing the second part of your request seeking details of any Human Resource plan or strategy under Section 30(1)(b) of the Freedom of Information Act, 2014 which states:

30. (1) A head may refuse to grant an FOI request if access to the record concerned could, in the opinion of the head, reasonably be expected to—

(b) have a significant, adverse effect on the performance by an FOI body of any of its functions relating to management (including industrial relations and management of its staff), or

Human Resource Management is in the process of developing a revised Human Resource strategy for An Garda Síochána. An integral part of this procedure involves a consultative process with various stakeholders, including representative groups. It is my opinion that releasing this document at this stage would adversely affect the outcome of these consultations

The eligibility requirements as sought in the final part of your request are detailed in Statutory Instrument 127 of 2012, Garda Síochána Act 2005 (Police Service of Northern Ireland Appointments) Regulations, which is attached for your convenience. I advise that the same eligibility requirements were applied to the previous competition run in 2014. Superintendent Michael Daly, formally of the P.S.N.I. was successful in that competition and was appointed to An Garda Síochána.

Right of appeal

The making of a late appeal may be permitted in appropriate circumstances.

GARDA SÍOCHÁNA ACT 2005 (POLICE SERVICE OF NORTHERN IRELAND APPOINTMENTS) REGULATIONS 2012

(Prn. A12/0662)

GARDA SÍOCHÁNA ACT 2005 (POLICE SERVICE OF NORTHERN IRELAND APPOINTMENTS) REGULATIONS 2012

I, ALAN SHATTER, Minister for Justice and Equality, in exercise of the powers conferred on me by sections 122(1)(d) and 125 of the Garda Síochána Act 2005 (No. 20 of 2005) (as adapted by the Justice and Law Reform (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No.138 of 2011)), after consultation with the Commissioner of the Garda Síochána and with the approval of the Government, hereby make the following regulations:

Citation

1. These Regulations may be cited as the Garda Síochána Act 2005 (Police Service of Northern Ireland Appointments) Regulations 2012.

Commencement

2. These Regulations come into operation on 13th March 2012.

Definition

3. In these regulations—

"competition" means a competition held in accordance with the Garda Síochána (Promotion) Regulations 2006 (S.I. No. 485 of 2006),

"promotion board" has the same meaning as it has in the Garda Síochána (Promotion) Regulations 2006,

"PSNI" means the Police Service of Northern Ireland.

Specified ranks

4. (1) The ranks specified in column 1 of the table to this regulation are specified as ranks that members of the PSNI must hold to be eligible for appointment by the Government under section 52 of the Garda Síochána Act 2005 (No. 20 of 2005) to ranks in the Garda Síochána prescribed under the Garda Síochána Act 2005 (Section 52) Regulations 2012 (S.I. No. 128 of 2012) and specified in column 2 of that table at the same reference number.

(2) For a member of the PSNI, other than a member who holds the rank of chief inspector, to be eligible for appointment to a rank specified in column 2 of the table it is necessary for that member to have held the rank specified in column 1 of the table at the same reference number for not less than the previous 2 years.

Eligibility for competition

5. (1) A member of the PSNI who is eligible under Regulation 4 for appointment to a rank in the Garda Síochána is eligible to be a candidate in a competition for promotion to that rank.

(2) No appointment of a member of the PSNI to a rank in the Garda Síochána shall be made other than in accordance with the selection of the promotion board concerned in a competition referred to in paragraph (1).

Notification of Chief Constable of vacancy

6. (1) The Garda Commissioner shall notify the Chief Constable of the intention to hold a competition for promotion to a rank specified in column 2 of the Table to Regulation 4.

(2) The Garda Commissioner shall do so in sufficient time to enable the Chief Constable to afford members of the PSNI an opportunity to enter a competition for promotion for which they are eligible.


(3) The Garda Commissioner shall provide the Chief Constable with a description of the role and a statement of the competencies required for carrying out the duties of the rank referred to in paragraph (1).

Application of Regulation 18 of the Garda Síochána (Promotion) Regulations 2006

7. Regulation 18 of the Garda Síochána (Promotion) Regulations 2006 applies to a member of the PSNI who enters a competition for promotion to a rank specified in column 2 of the Table to Regulation 4 as though that member of the PSNI was a member of the Garda Síochána.
