








Foreword

) am pleased to submit my annual report for 1995.

While crime continued on an upward trend, the overall increase during the year was the lowest of this decade and was confined to one per cent.

The steady increase in detection rates since the beginning of the decade reflects the efforts of An Garita Slochana to deal effectively with the extra workload. Detection in itself cannot provide the full answer to crime and related social problems. This fact is becoming broadly recognised and is reflected in the endeavours of the many agencies combining to address these issues.

My thanks are due to you and the Staff of the Department of Justice for the support received during the year. I must also pay tribute to the Customs National Drug Team and the Defence Forces for their assistance and cooperation, in air, ground and naval support.

Many outstanding successes in both covert and overt operations were due to the combined efforts of the different agencies and the continued co-operation of the public.

By the end of 1995 the decision to appoint Assistant Commissioners to five rural regions was finalised. The new appointees will be responsible for the operational efficacy of their respective regions.

This year's report features the role and responsibilities of a number of sections based at Garda Headquarters in the Phoenix Park. As these centralised sections provide essential services to An Garda Slochana, any significant reduction in personnel attached to them would have a serious effect on the overall performance of the Force. Prudence in deploying personnel between the various sections, recognising and taking into account the value and potential of each, continues to be a key challenge.

During the year the atmosphere in which serious crime was experienced became more influenced by a public anxiety to achieve instant success. While it is understandable that a growth in violence associated with crime increases fears, this cannot be allowed to encourage short cuts or hasty conclusions. Prudent investigation, professional assessment and a methodical approach take time and require greater patience. These methods were employed successfully during the year under review.






Crime Trends

Between 1990 and 1995 recorded crime increased from 87,658 offences to 102,484 offences or 17 percent. During the same period, the number of detected crimes increased from 28,985 offences to 39,753 offences or 37 percent. Chart 1 illustrates annual increases in recorded and detected crimes between 1990 an 1995. The rate of increase in recorded crime has been falling since 1993.












Chart 3 shows the breakdown of crime between the DMA, other city areas (Cork, Galway, Limerick, and Waterford) and rural areas for the years 1993 to 1995. The proportion of crime in each area has remained constant over this period.

Armed robberies and aggravated burglaries where firearms were used declined by 25 percent from 723 offences in 1993 to 542 offences in 1995. Chart 4 illustrates the number of recorded and detected offences for each year.



Armed robberies at financial institutions (banks, post offices, building societies and credit unions) decreased from 185 offences in 1993 to 100 offences in 1995, or 46%. (chart 5)







Chart 6 illustrates recorded and detected murders for the years 1993 to 1995.




About 50% of all crimes each year are burglaries (31%) and larcenias from unattended vehicles (18%). Chart 7 shows a percentage breakdown of 1995 crime by crime category.









During 1995, there was on average one house burglary for every 56 dwellings in the State.

Garda Headquarters Phoenix Park

The Garda Slochána has its headquarters in the Phoenix Park - one of the largest municipal parks in Europe - on the western side of Dublin city. The buildings occupied were purpose built as a police headquarters and have been in continuous use since circa 1842.

The general management and control of the Force is the responsibility of the Commissioner of An Garda Slochána who is appointed by the Government and is based at Headquarters.


Two Deputy Commissioners and three Assistant Commissioners are also based at Garda Headquarters. One Deputy Commissioner deals with Administration while the other has responsibility for operational matters.

Deputy Commissioner, Administration with the support of two Assistant Commissioners has responsibility for Personnel, Finance, Equipment, Training, Information Technology, Research and Development and the general administration of the Force.

Deputy Commissioner, Operations co-ordinates the operational activities of the Assistant Commissioner responsible for Crime & Security Branch and the Regional Assistant Commissioners.

The Garda Slochána by any criterion is in the forefront in policing practices, techniques and training. Support services of the highest calibre are required to maintain this standard and to meet the increasing demands placed upon the organisation.

The various sections which provide this high level support and expertise are in the main based at Garda Headquarters which comes under the control of Deputy Commissioner, Administration and his two Assistant Commissioners.







Press and Public Relations Office

The Garda Press Office operates all year round providing a comprehensive service to journalists, media students and the general public. As the number of radio stations and other media outlets continue to grow so does the varied requests for information and assistance which the office handles. This demand for information varies from calls for information about crime, traffic accidents and missing persons to requests for spokespersons on items of national interest. The office also deals with queries from the international media and provides an essential link in assisting foreign journalists working in Ireland on international stories.

Due to the increased numbers of local radio stations the office now instructs suitably selected members to assist their local radio stations. This has given Gardai access to the airwaves and has led to invaluable assistance being provided by the public. The Gardai depend on the co-operation of the public to be successful and the Garda Press Office will continue to utilise the many varied media outlets open to them to maximise public awareness.

The Garda Press Office also assists second level colleges by supplying personnel for career information lectures, where students interested in a career in An Garda Siochána are given information on what qualifications are needed for entry. This service provided by uniformed members also helps foster communication between young people and Gardal in a relaxed and informal environment.

Band of An Garda Síochána

The Band of An Garda Slochána was formed in 1922 and gave its first performance on Easter Monday, 1923 at Dun Laoghaire Pier, a short distance from Dublin City. In 1965, the Band was disbanded but was re-established in 1972 to celebrate the fiftieth anniversary of the foundation of the Force. The members of the present Band play a type of music that generally suits all tastes from the rousing traditional military airs right up to the popular music of today.

They are all full time professional musicians and during the course of each year give many concerts throughout Ireland. The special programme for their school concerts gives the Band enormous satisfaction as the children always enter fully into the spirit of the occasion and are



captivated by the variety of instruments in the Band and, of course, the music. The Band of An Garda Siochána was in Switzerland as guests of the Zurich City Police in 1977 and 1983. They were also participants in an international Police Band Festival in Basel in 1991.

1995 was the busiest year for the Band having performed in public on 203 occasions. The highlight of the year being a full Gala Concert in City Hall, Cork in October in celebration of the fiftieth anniversary of the foundation of the United Nations.

Garda Museum and Archives

The Garda Museum and Archives is now established as an essential multifaceted entity providing and co-ordinating services and policy in relation to the history and development of An Garda Slochána. The essential functions of the facility is to acquire, conserve and exhibit artifacts appropriate to the Museum thematic collection. At present the Garda Museum is in a state of preparation for its re-location to the Record Tower in Dublin Castle scheduled to take place in early 1996.

The function of the archives is likewise to ensure compliance with the terms of the National Archives Act 1986. The archivist continues to be available to assist in the co-ordination of this work by Imparting information and liaising with the officer of the National Archives responsible for Department of Justice and Garda records. A limited historical reference library and research facility will be maintained for use by Garda students and researchers who require access to Garda publications and original Garda historic material deposited in the Garda Museum.

Departmental records, however, will only be released after statutory certification through the National Archives.

Each year the Museum receives a steady flow of interested visitors from at home and abroad. Most of the visitors are likely to have family connections with An Garda Slochána, the Dublin Metropolitan Police or the Royal Irish Constabulary and early publications and personnel registers are a source of genealogical information which they exploit for mainly history purposes.







Central Reception Area

At the scene of most crimes, clues are left behind in many forms. Following an examination of the scene these clues are removed and taken to Garda Headquarters for expert examination and analysis. These clues which are classified as Exhibits must pass through the Central Reception Area. The purpose of this area is:

- 1. To record information in relation to all items submitted for Technical and/or Scientific examination.
- 2. To arrange for the return of all exhibits submitted to the station of origin after examination is completed.
- 3. Apart from these functions the Section also assists with the procurement of technical equipment and supplies for use by Scenes of Crime Examiners and the various expert services provided by the Technical Bureau.

Role and Aims of the Section

Part of the primary function of the Section is to allocate an identifier to all cases submitted for examination i.e. record in detail all items submitted for technical and forensic examination on the computerised exhibit tracking system. Allied to this is the function of recording details of all collections of exhibits by the investigating members or persons acting on their behalf.

Detective Training School

With the ever increasing sophistication in the commission of crime, the necessity to have a highly trained detective force is paramount. The Detective Training School meets these needs, and conducts detective training courses and Scenes of Crime Examiners Courses at Garda Headquarters. The courses are of a six and ten week duration respectively. The Detective Training Course objective is to equip members who have been selected for assignment to Detective Branch with the knowledge, skills and attitudes necessary to investigate all types of crimes.

Scene of Crime Examiners

The functions of this course is to train selected Garda personnel both uniformed and detective in recognising, identifying, collecting, marking, preserving, processing and submitting physical evidence from scenes of crime for laboratory

analysis and preserving the chain of evidence. They also take photographs and measurements of scenes of crimes and prepare sketches as needed.

The Detective Training School also conducts Photographic Courses for Scene of Crime Examiners.



Barrack Masters Section

In a national organisation such as An Garda Siochána with over 700 Garda stations and almost 11,000 personnel an effective policy for the purchasing and management of supplies is considered to be essential.

The section which comes under the control of the Barrack Master has responsibility for these functions which can be outlined as follows:


A. Accounting for and supplying all stock items of uniform clothing and equipment to the Force. This encompasses a considerable product range from vehicles/transport to the obvious such as standard items of uniform clothing to handcuffs, notebooks, whistles, riot gear, guns together with a multitude of other articles. The special requirements of members partaking in the various U.N. Missions serving in climatic conditions from tropical to arctic need to be catered for.

During the year a number of pilot projects have been put in place with the objective of further streamlining procedures in this area.

- B. The need to meet the requirements brought about by technological advances wherein office machinery equipment is constantly being upgraded together with supplying furniture, particularly to all of the new and refurbished stations that have come on stream in 1995.
- C. Maintaining the register of licensed and registered firearms.

In January 1995 Garda management established a study group to assess overall change requirements and needs for purchase and supplies management in the future, which among other matters will be looking at:

- policy and procedures
- organisation structures, roles and responsibilities
- physical infrastructure
- computer systems





Finance Section

The Finance Section prepare the Spending Estimates for the Force annually. This requires a very high degree of expertise and planning, to regularise the day to day running costs while also being mindful to ensure the very high standards needed for an effective modern police force.

All spending is approved through the Finance Section and the following is a sample list of areas of control.

- Transfer of Personnel Expenses
 - 2. Sanction of Financial Expenditure for Training Courses
 - 3. Purchasing of Equipment
 - 4. Travel Expenses/Subsistence Allowance
 - 5. Court Expenses Civilian Witnesses i.e. expert witnesses, expenses (doctors etc.)
 - 6. Advertising Budget
 - 7. Control of Overtime Spending
 - 8. Information for circulation to the Force.

Areas of Expenditure may change from time to time, and in this regard the Finance Section would take advice from the Barrack Masters Office.

Ballistics Section

Purpose of section

The Ballistics Section was formed in 1933, and was formally established in 1934, its function was to provide technical assistance to the Garda Siochana in matters relating to firearms, ammunition and explosives, and to give evidence in the Courts of Justice.

As a consequence of the increase and diversification of modern crime, the functions of the Section have expanded over the years, from our original concept of pure Ballistics to fill voids in certain areas within the force, as follows:

Matters dealt with

- 1. The examination of all firearms and ammunition, seized in relation to crime
- 2. The examination of all explosives and explosive devices seized within the state
- 3. The technical examination of the scenes of murder, suspicious death, and serious crime
- 4. The restoration of erased identification numbers on motor vehicles, pedal cycles, jewellery, electrical equipment, etc.
- 5. The inspection of firing ranges
- 6. Providing assistance in the investigation of arson

Scope of the section

The multiplicity of skills, and depth of experience which has evolved within the Section, is frequently called upon to assist in the investigation of various types of serious crime which occur in any part of the Country, many of these crimes are not firearms related.

Ballistics personnel technically examine the scenes of all murders and suspicious death, and attend at the subsequent Post Mortem examinations, whether firearms are involved or not. Because of the experience in dealing with dead bodies, they perform a technical role and assist the State Pathologist at the scenes and subsequent Post Mortems of the victims of all major disasters, e.g. The Stardust and Air India Aircraft Crash, etc.

The Ballistics Data Reference Centre, maintains records of all discharged cartridge cases and spent bullets recovered from crime scenes. All firearms received by the Section are examined and the bullets and cartridge cases test fired from them are microscopically compared with all previous shooting cases.


The Section is equipped with Microscope Rooms, Laboratory, Firearms Examination Room, Work Room, Firing Range and Bullet Recovery facilities.

There is also an extensive Reference Collection containing specimens of firearms, ammunition and explosive devices, which have come into our possession.

The Fingerprint Section

Purpose of the section

To provide a Fingerprint identification System for the Garda Siochana and to:

- Identify persons to their criminal records
- Authenticate criminal history data
- 1. Identify culprit to the scene of crime
- The identification of dead bodies
- Perform technical examination of major crime scenes.
- Provide specialist chemical and laser light fingermark development facilities
- 7. Provide expert fingerprint evidence at criminal trials and Coroner's Courts
- 8. Provide training in the science of fingerprints to Garda Personnel
- Provide a Facial Identification System (C.D.Fit) to enable injured parties and witnesses of crime to compose a facial likeness of the suspect

New developments in the fingerprint section

1. Chemical/laser examination and fingermark development unit

1995 saw the implementation of this Unit. It has the most up-to-date chemical and laser development techniques now available. Fingermarks can now be developed on articles/exhibits which was once thought impossible.

2. AFIS I AFR Introduced in the Technical Bureau

An Automatic Fingerprint Identification System/Automatic Fingerprint Retrieval System (AFIS/AFR) was installed in An Garda Slochana Technical Bureau in December 1995.

The matching of fingerprints using computer-based automation is known universally as automatic or automated fingerprint recognition and identification. The system comprises a database of fingerprints, a database of palmprints and a database of unsolved scenes of crime marks (latents). The system codifies the unique characteristics of each fingerprint, palmprint and latent impression and stores these codes in a computer database or repository of information.

The Garda Technical Bureau is recognised internationally for its role in solving difficult crimefrom 'cold' searches, that is, searches necessitating the comparison of a scenes-of-crime marks against the entire national collection of 150,000 cards or 1,500,000 fingermarks. The effort involved in undertaking this type of manual search was intensive, time consuming and cost!/ and, almost invariably, at the expense of an ever increasing work-load submitted from the operational force.

Live Scan

Live Scan is an Electronic Scanning Machine on which fingerprints can be recorded without the use of fingerprint ink. A screen is provided which shows the finger being scanned. When the quality of the impression is as required, the print can be recorded. Hard copies can be produced on a ten print format or the impression can be sent directly to the A.F.I.S. Work Station for process and search.

A Pilot System will be operational in 1996 at Mountjoy Prison and the Bridewell at Dublin and Cork. It has long been recognised that an alternative method to fingerprint ink had to be found to ensure top quality sets of fingerprints. Live Scan offers this potential.

Future plans

A new Fingerprint Mobile Laboratory Vehicle will be in operation in 1996. This will provide the facilities to use all the chemical/laser techniques available at major

crime scenes. It will also be fitted to avail of new scanning equipment now under test to enable fingerprints and fingermarks to be inputted directly per dedicated phonelines to the A.F.I.S. System for search. This, when operational, will be a huge step forward to speed up the identification process.

It is the goal of the Section to provide, where possible, a 24 hour turnabout of cases received.


Forensic Science Laboratory

In 1995 the laboratory received 8668 cases in total which was a 16% increase on the previous year. The greatest increase was in drug cases which went from 5379 to 6522 cases or an increase of 21%.

There was a significant increase in the amount of Heroin seized with smaller increases in Amphetamine and Cocaine. The greatest increase was in the number of Ecstasy cases which went from in excess of 300 to nearly 600 cases.

The lab dealt with 43 DNA cases and of particular relevance was the trial of a man charged with murder who was eventually convicted and in which there was a particularly vigorous but unsuccessful challenge by the defence.







Photographic Section

Matters dealt with and scope of the section

The section provides for the photographic needs of the Garda Slochána and through its training is equipped to deal with a wide range of demands from a public Relations assignment to the complexities of a major disaster.

Matters dealt with include assisting photographically in the investigation of crime. Providing both evidential and illustrative photographs to assist investigators and providing albums of , photographs to assist the courts

- Photographing scenes of major crimes and disasters.
- Assisting the presentation of court cases by providing photographic evidence.
- Photographic material for use by the Public Relations Office
 - Fingermark and footmark photography
- Copy work, Archival and current scenes.
- Processing and printing scenes photographed by Scenes of Crime Examiners countrywide
- Providing photographic stills from security videos
- Issuing J.D. cards to members of the Gardal

All of the above photographic disciplines ensure that a professional service is at all times available to assist in the investigation of crime.

Future aims and plans

To continue to provide a professional service to the Force using existing techniques and by embracing new technology in the photographic field. To ensure that new members in the Section are properly trained in Forensic Photography. To research and evaluate new approaches including digital applications pertinent to photography.



Garda Criminal Records Office

This Section deals with the following:

G.C.R.O. receive and file information in relation to convicted criminals and maintain a nominal and street index for persons convicted of indictable crimes. With the exception of secondary files the information is available on computer in Garda Stations throughout the country.

Matters dealt with in G.C.R.O. include the checking of applicants for various positions such as Garda and Civil Service appointments, Child Care Workers and persons who need to work in high risk security areas.

Handwriting / Document Section

The Handwriting/Document Section was formed in 1973 as a sub-section of the Garda Technical Bureau. The demand for the section came, because of the rapid growth in both volume and variations of documents in use in business and personal transactions, inevitably more of these documents would be used in criminal activities.


The quantity, quality and complexity of cases have increased dramatically over the last few years. The section has been involved in many of the recent major high profile investigations. All staff attached to this section are recognised as experts in their field. The Document Section gives valuable support and advice in the investigation of crime.

Garda Mapping Section

The Garda Mapping Section is one of the Technical Bureau sections which, since its formation in 1934, has been providing a comprehensive mapping service for the force. This service includes the provision of all the administrative maps for all Garda Stations throughout the state, as well as surveying and preparing scaled drawings and maps of all serious crime and accident scenes. In addition the section prepares security maps and services for major events and V.I.P. visits.

Most of the work, however, carried out by the staff of the Mapping Section relates to criminal cases. This will involve a mapper visiting the scene, recording all detail of relevance, drafting

scaled drawings of same, making a report, attending court and tendering evidence in the subsequent case. All of the staff in the section are surveyors, who were selected from within the force. In 1995 there were 375 approved applications for mapping services received by the section, 35 of which involved scenes where murder was suspected.





Housing Section

There are 704 Garda Stations throughout the 26 counties. Many of these Stations date back to the formation days of the Force and were originally part of the old RIC structure. The need to upgrade these buildings was given priority in the early sixties with the appointment of a Superintendent Housing Officer. Since that time, great strides have been made in bringing Stations throughout the Country to the high standards expected and required in today's society.

During the course of 1995, a number of new Stations, such as Blackrock, were built and others refurbished. Other projects commenced during the year. Additionally, plans were put in place for works to commence in 1996.

The Housing Section of the Garda Slochana has a key role in identifying and progressing the needs of the force in this important area.

Investigation Section

The Investigation Section is part of Crime Branch, Garda Headquarters, Phoenix Park. During 1995 the Unit has assisted in the investigation of murders, manslaughters, kidnappings, extortion, paedophile cases, hijackings and other categories of serious crime throughout the twenty-six counties.

The Unit has provided training courses in crime investigation techniques for selected members for Garda divisions countrywide. The Investigation Section provides a key role within An Garda Slochana in the investigation and detection of serious crime.

Art and Antiques Unit

The Art and Antiques Unit was established in 1995 as part of the Investigation Section. It comes under the control of a Detective Superintendent and there is a Divisional Liaison member in each Division throughout the country.

Liaison has been established with the Art and Antique Dealers Associations and with a number of other interested organisations in structuring a coordinated approach to the theft of items of Art and Antiques.

Similarly liaison has been established with the Art Loss Register, Trace Magazine and the Antique Trade Gazette, all based in Great Britain and having offices at European and world-wide locations. In this way descriptive details of stolen items are circulated through auction houses and dealers. Liaison has been established with Police Forces engaged in similar type investigations.

Though the Unit is relatively new it has been successful in recovering stolen items of Art and Antiques to a value in excess of £1m during 1995.









Drug Situation Report 1995

in terms of drug seizures, 1995 was the most successful year to date for An Garda Siochána. As stated in the 1994 report supply and demand strategies operating within the force are continually reviewed and reinforced; such strategies have greatly assisted in the success of the year under review. The formation of the new Garda National Drugs Unit in September 1995 also greatly attributed to this success.

The Garda National Drugs Unit's primary function is to target major drug traffickers as well as 'monitoring, controlling and evaluating all 'drug' intelligence and policies within An Garda Siochána.

The successes of An Garda Siochána during 1995 and in particular the latter quarter of 1995 after the formation of the Garda National Drugs Unit included the seizure of:

- 1. 1.5 kg of Amphetamines in Cork on 11/2
- 2. 95 kg of Cannabis Resin in Cork on 24/3
- 3. 2 tons of Cannabis Resin at Dublin Port on 31/3
- 4. 40,000 Ecstasy tablets in Santry on 11/7
- 5. 13 tons of Cannabis Resin at Urlingford on B/11
- 6. 1 kg of Cocaine at South Circular Road on 1/12

In addition, two Dublin premises searched in June 1995 where illegal substances were located suggest that these premises were used in the manufacturing of Ecstasy tablets.

The increased co-operation between the Gardal, Naval Authorities and the Customs National Drugs Team (CNDT) greatly assisted in the success of the Garda authorities throughout 1995. It is envisaged that co-operation will be greatly enhanced with the CNDT by the exchange of liaison officers at both national and local level. In addition, a Joint Task Force comprising of the above three agencies will meet when the occasion arises to undertake intelligence-driven operations against drug smuggling.

In addition to tackling the supply side of the drug problem the Gardaí have also concentrated on reducing the demand for drugs by the introduction of a Drugs Awareness Programme. This Programme involves local Gardaí giving talks and advice to various groups throughout the country. Our commitment to educating the general public about the dangers of drug abuse is evident from the attached drug statistics which indicate that approximately 55 lectures/talks per week were given by members of An Garda Siochána during 1995.





Traffic Section

The Garda Traffic Branch based at Garda Headquarters, Phoenix Park, has responsibility for implementing policy in relation to Traffic Law enforcement throughout the country. As we move into 1996 we see ourselves identifying and highlighting the various causes of road deaths and injuries with a view to targeting areas of Road Traffic Enforcement which can contribute to a reduction in fatalities and injuries. These will include the areas of Speeding, Drunk Driving, Dangerous Driving and Careless Driving, Breaches of General Bye-laws, wearing of Seat belts and Pedestrian visibility

During 1995 the Section was involved in many varied activities including the following:-

1. Road death and road injury statistics

Details of all road deaths and injuries throughout the country are compiled at this office. Close Ilaison is maintained with the National Roads Authority, the National Safety Council, The Insurance Federation of Ireland, Departments of Justice and Environment with a view to coordinate all parties in their efforts to bring about a greater Road Safety Awareness.

2. Enforcement of drink driving laws

The enforcement of Drink Driving Legislation throughout the State is monitored by Traffic Branch at Garda Headquarters. The number of arrests for Drink Driving during the year 1995 dropped by approximately 1,000 on 1994.

3. School Wardens

The setting up of Junior School Warden Systems throughout the country are co-ordinated by the Traffic Branch following approval by the Garda Commissioner.

4. Administration of Traffic Corps and implementation of Speedtrack Programme

The greater emphasis on Speed Limit Enforcement which has been the case over past years, was continued with an extension of the Garda "Speedtrack" programme. This involved the coordination of adjoining Divisions so that high visibility speed enforcement is the order of the day. Regular uniformed members linked with Traffic Corps in this regard.

5. Liaison

Traffic Branch maintain lialson with a large number of organisations including Department of Justice, Department of the Environment, Department of Health, National Roads Authority, National Safety Council and Irish Insurance Federation among others.

6. Lectures

The Superintendent from Traffic Section delivers lectures at the Sergeants Promotion Courses at the Garda Training College, Templemore and at the In-Service Training School, Harcourt Square.

Major Emergency Plan

This area also fails within our remit and a survey was carried out into the up to date position of local Major Emergency Plans in each Division and all plans were updated.







The Garda Bureau of Fraud Investigation

The Garda Bureau of Fraud Investigation was established in April, 1995 In Ilne with the recommendations of the Government Advisory Committee on Fraud. The Bureau is now under the control of a Chief Superintendent who in turn is responsible to the Assistant Commissioner in charge of Crime and Security Branch at Garda Headquarters, Phoenix Park. The Bureau is based at Harcourt Square, Dublin 2.

² The Bureau's role is to lead the investigation of Fraud on a national basis. The Garda staff at the Bureau concentrate on the more complex cases of fraud reported to An Garda Síochána while the less serious cases are investigated by Gardaí at local level.

The objectives of the Bureau may be summarised as follows;

- 1. To investigate serious cases of commercial fraud, cheque and credit card fraud, computer fraud, money laundering offences and counterfeit currency
- 2. To collate information and intelligence and act as a resource centre on fraud related matters
- 3. To play a pro-active role in the prevention and detection of fraud

Structure of the Garda Bureau of Fraud Investigation

The Bureau carries out its functions through the following units:

1. Assessment Unit

The assessment unit has responsibility for analysing and reviewing each complaint made to the Bureau with a view to:

- A. Establishing if a crime is disclosed requiring Garda action
- B. Make recommendations as to the scope and nature of the required investigation

Cases assessed are then referred to local Gardal for investigation, while the more complex ones are investigated by the Bureau itself. The Unit also handles numerous enquiries from European and other police forces transmitted via Interpol, and collates information on fraud suspects, companies and vehicles.

2. Commercial Fraud Units

The main function of the Garda Bureau of Fraud Investigation is the investigation of serious and complex Commercial Fraud cases. Complaints are received from financial institutions, business firms, Government Departments, Insurance Companies, the Director of Public Prosecutions the Revenue Commissioners and individual citizens.

3. ChequelCredit Card Fraud Unit

This Section is exclusively engaged in the investigation of cheque/credit card fraud and counterfeit currency. The Unit concentrates on the more serious cases of this nature.

4. Computer Crime Unit

This Unit is the national reference point for computer related crime. It also has the responsibility for investigating computer related fraud, assisting other Garda Units with the identification and extraction of computer based evidence and advising on security measures for combating computer crime.

5. Money Laundering Investigation Unit:

This Unit was set up in May 1995 in conjunction with the enactment of the Criminal Justice Act 1994. It is actively involved in recording, evaluation, analysis and investigation of disclosures received from designated bodies.

The work carried out by the Bureau is wide and varied and the staff liaise widely with the business and commercial sector in the performance of their duties. The experience and expertise within the Bureau can be availed of by other sections of the force. In addition the Bureau plays an active role in training other members by way of Fraud Lectures to promotion, C.I.D. and In-Service training courses. 'It also provides advice to Accountancy Bodies, Banking Institutions, Traders and other Security Groups.

Fraud statistics/intellegence

In 1995 a total of 1162 Fraud Offences were reported to the Bureau. A total of 72 persons were charged by the Bureau with Fraud related offences during the year.

A collator is attached to the assessment unit of the Bureau. His/her functions are:

- To collect and analyse information on suspect companies/individuals to enable the Bureau act as a resource centre on fraud related matters
- To liaise and deal with fraud enquiries from within the Garda Slochána and other police forces

The Bureau maintains full and complete statistics on fraud complaints received, investigations undertaken and prosecutions instituted.

Common criminal offences investigated by the Bureau are:

- Breaches of the Companies Acts
- Breaches of the Insurance Acts
- Falsification of Accounts
- False Pretenses
- Forgery
- Offences under Criminal Justice Act 1994 i.e. Money Laundering
- Conspiracy to defraud
- Fraudulent Conversion
- Larceny
- Embezzlement

The establishment of the Garda Bureau of Fraud Investigation has streamlined the efforts of An Garda Siochána to tackle the serious threat presented by fraudulent behaviour to Irish commercial activity. Additionally, the Bureau provides a vital educational role in advising the public at large on the prevention and avoidance of fraud-type offences in the Community.



Garda IT Centre

Background

An Garda Siochána has embarked one of the most significant developments in Information Technology (IT) ever undertaken by an Irish public service organisation. This development will see the introduction of new operational and administrative systems to enable the Force to meet its organisational goals.

The Garda Siochána Corporate Strategy Policy Document, 1993-1997 was published in April 1993. This document articulated the mission of An Garda Siochána, identified the organisational goals and the means of attaining those goals that would enable the service to comply with its mission.



One of the identified vehicles for achieving those goals was expanding and utilising to the full the benefits of IT.

An Garda Slochána, assisted by Consultants, undertook the development of a Strategic IT Review, to assess:

- what are the current and future directions of IT?
- what is the potential of IT in a police environment?
- how have existing Garda computer systems assisted the Force?
- to what extent can existing systems be adapted to meet requirements?

A plan was accepted by Garda management, and was part of the Law and Order package submitted to and approved by the Government in late 1993.



The next phase, commenced in 1994, was the Conceptual Design following a competitive tendering process. The conceptual design team carried out a detailed examination of operational and administrative areas of the Force.

Part of the process included interviews with over 200 members of An Garda Siochana of all ranks. These members represented the 'users', i.e. those who would be using the systems. A Chief Superintendent, seconded from 'B' Branch, was appointed as User Liaison Co-ordinator. His function was to set up these specialist user groups.

1995 Developments

As a result of the Conceptual Design, a comprehensive Request For Tender (RFT) was published, detailing the perceived IT requirements of An Garda Slochána. During 1995, the responses to these tenders were evaluated, and a preferred supplier will be selected in early 1996. Following this, the next stage of the IT Strategy will commence, which is the detailed design and build phase. Work is also proceeding in ancillary areas. The network requirements of the system are boing addressed, PC's have been installed to provide office systems facilities, and an AFIS/AFR (Automatic Fingerprint Identification System/ Automatic Fingerprint Retrieval) has been introduced in the Technical Bureau.

Also during 1995, work was undertaken in several 'niche' computer areas. These included:

- a Money laundering System for the Garda Bureau of Fraud Investigation (GBFI).
- the identification of a Fleet management system for the Garda Transport division,
- a new Alarm Monitoring System for divisional offices outside the DMA, assist them in complying with An Garda Slochána Alarm Policy.
- an Exhibit Tracking system for the Technical Bureau,
- an incident recording system for the Communications Room, Anglesea Street, Cork, to compliment the new Cork Radio system,
- an on-line reference material pilot system, using the Finance Code as the source document.
- word processing templates for commonly used documents and forms.
- on line Charge Sheet Wordings

Also during 1995, an Inspector from the Garda IT Centre was selected from a Europe wide competition for IT System Development Officer at Europol, Drugs Unit, in The Hague. The position was advertised to all EU custom and excise services and police forces.



Garda Community Relations Section

The Section comprises of the National Juvenile Office, Schools Programme Office, National Crime Prevention Office and Crimeline. The Section has responsibility for formulating, implementing and evaluating all crime prevention programmes and measures utilised by An Garda Siochána.

Specific responsibilities of the Section include: Neighbourhood Policing; Neighbourhood Watch; which celebrated its 10th anniversary during 1995; Community Alert which made available a revised video and literature in 1995; Victim Support which has 14 branches in operation; Business Watch which has 49 schemes operating; Campus Watch which is operating in 10 third level institutions; Crime Prevention Literature on Yourist Security, Child Protection, Senior Citizen Advice, Vandalism, Safety for Women, Safe housekeeping and Drug Prevention Advice; Crime Prevention Stands which were utilised at major exhibitions; and Mobile Drug/Crime Prevention Stand which were utilised at major exhibitions; and mobile Drug/Crime Prevention Stand which were utilised at agricultural shows, shopping centres, schools and town centres. All of these areas continued to expand and develop during 1995.

National Juvenile Office

Responsibilities of the Office include the overall administration of the Juvenile Diversion Programme; the development and implementation of the Garda Schools Programme; supervision, support and training of Juvenile Liaison officers and on-going liaison and contact with statutory and non-statutory bodies involved in the area of juveniles.

Garda Juvenile Diversion Programme

The programme provides for the cautioning (warning) of juvenile offenders under 18 years of age as an alternative to prosecution. Since inception in 1963 some 75,656 young people have benefited from inclusion in the programme.

Garda Schools Programme

The Garda Schools Programme operates in all Garda Divisions. The aim of the Programme, designed for fifth class primary school pupils, is to teach children sensible and responsible patterns of behaviour in order to lessen the risks faced by them by crime, be safer on the roads and at home, positively contribute towards crime prevention, know what the role of the Gardal is, and develop positive attitudes towards the Gardaí and the job they do.

Crime Prevention

In 1995 National Crime Prevention Office staff gave 24 talks and carried out 129 commercial surveys and 63 security surveys.

In December 1995, one member attended a seminar on 'Approaches to Designing Out Crime'. This was an invaluable opportunity for the Garda Slochána to acquire an insight into the concept of architectural liaison practices which utilises the principles of designing out crime.

Community Based Projects

Garda Slochána special projects are multi-agency and are funded by the Department of Justice and aim at providing services for young people at risk in a defined community, with the objective of preventing participants becoming involved in criminal behaviour.

In 1995, two further projects were launched by the Minister for Justice, giving a total of seven such projects.

Crimeline

During 1995, ten programmes were broadcast and they enjoyed top tam ratings among viewing audiences. The programme continues to prove successful in the detection of crime.

Garda Transport Section

There are 1,572 vehicles in the Garda fleet. These include cars for the President and Government ministers, patrol cars, motorbikes, vans, tow-trucks etc. The Garda Transport Section has responsibility for the allocation of these resources together with ensuring their proper maintenance.

The Garda Garage provides service and maintenance in respect of ministerial transport and other Dublin based vehicles including specialist units. In addition garage personnel provide a very valuable back-up service in the screening of vehicles from a security aspect and in providing auxiliary lighting at crime scenes.

The Transport Section includes a pool of experienced drivers whose work includes conveying prisoners to courts and prisons around the country, transporting juries and providing back-up transport for all sporting and special events.

All the drivers of the presidential and ministerial cars who also act as security escorts are drawn from the Garda Transport Section.









Closed Circuit Television in the Temple Bar Area

The Temple Bar area of Dublin was chosen for a pilot project in crime prevention and detection by use of close circuit television(CCTV). The project was jointly funded by the Dept. Of Justice and Temple Bar Properties and was launched on the 26th October 1995.

Cameras have been strategically placed in the Temple Bar Area with a monitoring station at Pearse Street Garda Station. Movements In the area are monitored 24 hours a day, 7 days a week.

A decision on future policy in this area will be made on foot of a review of this pilot project.



Telecommunications Section

The Telecommunications Section has responsibility for radio, telephones, computer network and installation of computer hardware within the Garda Slochána.

Review of An Garda Síochána

'B' Branch

Personnel Section ('8' Branch) is based at Garda Headquarters, Phoenix Park, Dublin 8 and is under the control of an Assistant Commissioner. It exists to provide a service for the membership of the Force, in addition to civilians attached to An Garda. Slochána, relating to all facets of the ever increasing personnel function.

It is a Branch where time constraints are of the essence and a through up-to date knowledge of legislation, regulations' and E.U. directives is reguired to ensure, that the Garda membership and Garda management receive the best possible service.



Strength of the Force

The breakdown of the strength by rank as and from 1st January, 1996 is as follows:

Transfers

The number of transfers effected during the period from 1st January, 1995 to 31st December, 1995 was 1,699. These transfers include allocations on completion of training and allocations of existing personnel on promotion and consequential transfer.



Recruitment

In 1995 a total of 350 Garda Trainees were inducted to training at the Garda College comprising of 281 males and 69 females.

Retirements

A total of 446 members were discharged from the Force during 1995. This number included 398 retirements, 22 resignations, 9 incapacitations, 3 dismissals, 1 discharged on probation and 13 deaths of serving members. A total of 77 former members died during the year.

Civilianisation

The number of civilian clerical staff in An Garda Siochana at present is approximately 679. This number is not expected to increase significantly in the foreseeable future.

In addition to the civilian clerical staff working with An Garda Slochana, there are 168 Traffic Wardens and approximately 151 civilians employed as full-time general operatives, services attendants, storemen and cleaners. There are approximately 600 part-time cleaners and services attendants.

Promotion

In 1995, competitions were conducted for promotion to the rank of Chief Superintendent, Superintendent, inspector and Sergeant. The number of applicants and successful candidates were

In 1995 one hundred and eighty five (185) Gardal were promoted to the rank of Sergeant, five of which were as a result of promotions in specialist areas.

Seven (7) Regional Interview Boards sat for promotions to the rank of Sergeant and five (5) for promotion to the rank of Inspector. This included separate Boards for candidates serving with the U.N. in Cyprus and Yugoslavia. Successful candidates went on to be interviewed by a final Central Interview Board. In the case of promotions to Chief Superintendent and Superintendent ranks respectively, a central Interview Board assessed the candidates. The four competitions terminated in late 1995 with the promulgation of the lists of successful candidates. In 1995 there was 7 appointments to Chief Superintendent, 25 to Superintendent, 41 to Inspector and 185 to Sergeant rank. This gave a total of 258 promotions in 1995. 213 Gardaí were successful in the written Sergeants' Promotion Examination and 76 Sergeants in the Inspectors' Examination.

Scott Medals

Scott Medal awards are made annually and the minister for Justice presents the medals to the recipients at a ceremony at the Garda College, Templemore. this year the Minister presented 1 gold and 7 bronze medals to members of an Garda Siochána. To date, 304 medals have been awarded, comprising 68 gold, 103 silver and 133 bronze.

Performance Development and Review

Training for members of An Garda Slochána of all ranks in the working of the Performance Development and Review system was completed during 1995.

Discussions with representatives of the Association of Garda Sergeants and Inspectors and the Garda Representative Association are ongoing in order to bring all ranks into the system.

Safety, Health and Welfare

The office of Safety, Health and Welfare at Personnel Section continues to deal with all such matters pertaining to this area within An Garda Slochána. Training at all levels continues to be given in Safety, Health and Welfare at the Garda College and at In-Service training centres. During 1995, seminars were held for all Chief Superintendents and Superintendents. The training programme for peer supporters was finalised in 1995.

In 1995, An Garda Siochána was the recipient of a Certificate of Merit for Occupational Health and Safety from the National Irish Safety Organisation. This award was made in recognition of the achievement of the Garda Siochána in securing safety, health and welfare at work.

Discipline in the Garda Síochána

The Regulations governing Garda behaviour are contained in the Garda Siochana (Discipline) Regulations, 1989 (S.I. No.94 of 1989).

A total of 319 new cases were reported to the Discipline Section in Garda Headquarters during 1995. This figure includes a total of 67 cases where legal proceedings were proposed against the Gardaí for incidents arising in the course of discharging their duties, e.g. alleged assault, wrongful arrest, etc. (but not including traffic accidents involving official vehicles).

A number of cases were carried over from the previous year leaving a total of 505 active files on hand at the end of 1995. A total of seventy seven (77) cases were proceeded with formally under the Garda Slochána (Discipline) Regulations, 1989. The remainder were dealt with informally or were not proceeded with. Those formally dealt with involved Sworn Inquiries, disposal by local Divisional Officers in accordance with Regulation 13 and those who were dismissed or who resigned as a result of proceedings in accordance with Regulation 40.

Overseas Service with the United Nations and European Union - Members of An Garda Síochána

The following Garda Contingents were deployed to overseas missions during 1995.

In 1989, the first Garda Contingent was deployed to serve overseas with the United Nations and in the intervening years a further 13 Contingents have been deployed to serve with either the United Nations or the European Union. A total of 326 members have served on overseas duty in the following mission areas:

Namibia, Angola, El Salvador, Former Yugoslavia, Mozambique, Somalia, Cambodia South Africa, Cyprus, Western Sahara, Tajikistan and Palestine.

Members of An Garda Siochána working with the united Nations and European union on Peacekeeping missions have been recognised for the professional and dedicated manner in which they carry out their duties. An Garda Siochána are fully committed in trying to establish peace and democracy in countries which have experienced internal conflicts and civil war.

United Nations Mission in Cyprus (UNFICYP) - 14 members

The mandate of UNFICYP is to prevent the renewal of fighting between the different ethnic groups in Cyprus by maintaining a peaceful atmosphere within which a just and lasting solution to the Cyprus problem can be found, and to provide appropriate assistance for humanitarian agencies.

Functions:

The Garda Contingent are responsible, primarily in or with respect to the Buffer Zone, for the following activities not involving UN personnel or UN property:

- A. Investigation of criminal offenses committed or suspected of being committed by non-UN personnel.
- B. Preservation of civil order in the Buffer Zone.



- C. Resolution of disputes between civilians from the North and South.
- D. Access control of civilians in the Buffer Zone, Supporting UNFICYP in the control of civilians during demonstrations, disturbances etc.
- E. Assistance and monitoring of CYPOL investigations in the Buffer Zone.
- F. Escorts of civilian officials into the Buffer Zone.
- G. Investigation, including custody of would-be defectors.

United Nations Mission in former Yugoslavia (UNPROFOR) - 20 members.

Tour of duty is of 12 months duration.

-Functions:

- A. To monitor the local police force, to ensure that they carry out their duties without discrimination against any person or any nationality.
- B. Patrol and Control of the Separation Zone in the United Nations Protected Areas (UNPAs).
- C. To ensure that local police respect the human rights of all residents in the mission area.
- D. To provide appropriate assistance to UNHCR (United Nations High Commission for Refugees), ICRC and other UNPROFOR recognised humanitarian agencies in support of their work to facilitate the return, in conditions of safety and security, of civilians who have been displaced by the conflict.

European Union - International Conference in the Federal Republic of Yugoslavia (ICFY) - 3 members.

Function:

To monitor the arms embargo with regard to the Serbo-Montenegro border with Bosnia.

United Nations Mission for the Referendum in Western Sahara - 35 members *Functions:*

- A. The supervision and monitoring of the work of local police forces, to ensure that law and order is maintained effectively and impartially, and that human rights and fundamental freedoms are observed and fully protected.
- B. Supervision of prison and detention centres.
- C. The supervision of a free and fair referendum.
- D. Assisting in the process of returning persons displaced by hostilities.
- E. Investigate crimes and complaints of discrimination or other human rights abuses.

United Nations Mission to Tajikstan - 1 member.

Function:

Legal/Judicial consultant to the Tajikstan authorities working closely with UNHCR (United Nations High Commission for Refugees).

European Union Electoral Unit Mission to Palestine - 1 member.

Function: Observing/Monitoring democratic elections in Palestine.


