Message from the Commissioner

During the month of February 2024, the "It's A Job Worth Doing" Garda recruitment campaign closed, yielding over 6,380 applications. This competition was the first ever that invited applications from those up to 50 years of age. This clearly bolstered our applications, with almost 40% of those who applied in the 35-49 age bracket. Furthermore, almost 25% noted their ethnicity as being other than white Irish. The number of applications supports our view that people continue to see policing as a good career choice and value the role they can play in society by becoming a member of An Garda Síochána.

Indeed, this was borne out by the great efforts made by Probationer Gardaí, Garda Callum Hegarty and Garda Thomas Hayes, and Trainee Garda Joe Stubbings, who were called upon to assist a man in cardiac arrest while on beat patrol in Dublin City Centre. Together they took turns performing CPR while further medical help was sought. This is just one example of our new recruits stepping up to the mark and making a real difference in people's lives.

The good work continued elsewhere as well. February 2024 saw a number of high profile and high value drug seizures, including the seizure of €30m worth of suspected illegal drugs. This formed part of a joint operation with Revenue at Cork Port, and subsequently resulted in arrests and the seizure of two firearms. Further to this, the Garda National Drugs and Organised Crime Bureau seized approximately €3m worth of suspected drugs in Dublin.

Work continues with our partners in policing and other agencies. This month I attended this year's Cross-Border Organised Crime Conference, the first since 2019. Working with our law enforcement partners not only in the PSNI, but also the Revenue Commissioners, CAB, the National Crime Agency, HM Revenue and Customs, and UK Immigration Enforcement, our joint efforts prevent and detect serious crimes that adversely impact on border communities.

As I have said previously, one of the biggest challenges for all law enforcement right now is the increased international nature of crime. Established networks like the Cross-Border Joint Agency Task Force are instrumental in detecting and stamping out international crime networks. It takes a network to defeat a network.

Road fatalities have risen in the first two months of this year. An Garda Síochána remains committed to promoting road safety. This month, we partnered with young people to re-affirm key life saver messages. It was my pleasure to meet with primary school children in Tullamore as they highlighted a key road safety message: "phone down – safe driving".

Further to this initiative, An Garda Síochána held a media briefing ahead of the St. Brigid's Day bank holiday weekend on 1 February 2024 at the University of Limerick (UL). At this event, we highlighted a collaborative road safety project with UL students aimed at positively affecting young driver behaviour. Meanwhile, road safety enforcement operations took place across the country, with operations in Cavan and Kilkenny promoted on 4 and 5 February 2024. Lastly, our first National Slow Down Day of 2024 was held on 29 February 2024.

An Garda Síochána continues to advise the public to stay safe on our roads by adhering to the speed limits, wear your seatbelt, never drive under the influence of drink or drugs and to put the phone down.

1. Finance

The total gross 2024 allocation for An Garda Síochána is €2.36b and net allocation is €2.25b. At the end of February 2024, the total combined gross expenditure is €361.1m (15% of allocation), which is less than the end of February 2024 profiled spend by €5.49m, with further detail below on specific areas of over/under profile.

Current Allocation and Expenditure

The gross current allocation for 2024 is €2.19b, which includes pay of €1.47b (including pay for the Garda College). Expenditure on pay in February 2024 was €138.5m and year to date is €249.94m. Expenditure on the salaries, allowances and Employer PRSI elements in February 2024 was €124.1m, and year to date is €221.02m, which is €2.14m under budget profile. Expenditure on overtime in February 2024 was €14.4m and year to date is €28.92m, which is €2.53m over budget profile. Overall, pay and overtime is over the profiled budget by €0.39m at the end of February 2024.

In respect of superannuation of €458.05m, expenditure in February 2024 was €33.44m and year to date is €68.4m, which is €1.42m under profile at the end of February 2024. Other non-pay subheads of €259.23m (including for the Garda College). Expenditure on non-pay in February 2024 was €13.5m and year to date is €28.77m. Overall, non-pay expenditure is €4.32m under profile at the end of February 2024, considered in the main due to timing of receipt of goods or services.

Capital Allocation and Expenditure

The gross capital allocation for 2024 is €165.86m (excluding deferred capital). €15m of deferred capital has been carried in to 2024. Expenditure on capital (including the Garda College) in February 2024 was €6.58m and year to date is €13.99m. The capital subheads have a combined under profile spend of €0.14m to the end of February 2024.

Appropriations in Aid

Appropriations in Aid were €21.44m at the end of February 2024, €3.24m ahead of the estimated profiled receipts.

Estate Management February 2024

The following projects are currently onsite and are the subject of active engagement between the OPW and An Garda Síochána;

- Clyde House, Dublin 15: An Garda Síochána personnel moved in late November 2023.
- J-Block, Garda HQ: An Garda Síochána personnel moved in February 2024.
- Bailieboro Garda Station: The anticipated completion date is Q1 2025.
- Redevelopment of Portlaoise Garda Station: External enabling works at the main station have been completed. Decant options for the main redevelopment are currently being finalised. Tenders for the main refurbishment of Portlaoise Garda Station were published by the OPW on 21 December 2023. This is a two stage process. The deadline for receipt of submissions for the main works has been extended from 15 February 2024 to 19 March 2024, due to pressures in the construction industry.
- Redevelopment of Slane Official Accommodation: Contractor commenced onsite in Q4 2023. It is due for completion by the end of March 2024. The works comprise conversion of former official accommodation into office accommodation for the Divisional Protective Services Unit.

Other projects at earlier stages of development, which continue to be progressed in conjunction with the OPW, include the following;

- Drogheda PEMS and Locker Room/Tallaght PEMS/Naas PEMS: The main tender package for Drogheda PEMS and locker room has issued. The target is to commence works onsite in Q1 2024, with an estimated 12-month construction programme. Tallaght and Naas to follow, subsequent to the main works contract starting onsite in Drogheda.
- Newcastlewest Garda Station: Planning permission for a new District Headquarters at Newcastlewest, Co. Limerick has been granted. Demolition of the old station commenced in Q4 2023 and was completed before Christmas 2023. The tender for main contract was issued on 29 February 2024.
- **Cell Refurbishment Programme:** Works are ongoing at Cobh and Athy Garda Stations, with anticipated completion dates at the end of March 2024.
- Clonmel and Macroom: Garda Estate Management is in discussion with the OPW and local management on these developments. Plans have been signed off, in principle and are with the OPW for tender pack preparation.

2. Human Resources and People Development

Key Human Resources and People Development Highlights

Roster Duty Management System (RDMS)

- Go live on RDMS was completed in Governance and Accountability, Human Resources and People Development, Information and Technology, Strategy and Transformation, and Legal on 6 February 2024.
- RDMS recently went 'live' in Liaison and Protection, Garda National Roads Policing and Community Engagement Bureau, and Finance Procurement on 26 February 2024.
- The remaining DMR regional resources and North Western regional resources are due to go live on RDMS on 19 March 2024.
- A85s (record of duty and claim form for overtime, and other allowances) continue to be retired across live divisions, most recently in the Garda National Bureau of Criminal Investigation, and in Security and Intelligence on 19 February 2024.
- There are circa 98% of Garda members using RDMS for duty planning and to book on/off.

Health and Safety

44 occupational injuries were recorded for February (as of 05/03/24).



- The number of National Incident Management System (NIMS) incidents created in February 2024 is 129 (as of 05/03/24).
- Training carried out by the Health and Safety Unit in February 2024:

Fire Warden Training:

- 15 personnel were trained as fire wardens in the Laois/Offaly Division.
- 37 personnel were trained as fire wardens in the Southern Region.

Safety Representative Training:

- 12 personnel were trained as safety representatives in the Cork County Division.
- Scheduled health and safety trainings for March 2024:
 Safety Representative Training: Kerry Division, Cork Divisions and Limerick Division.

Workforce Planning

- The Workforce Planning Team is continuing to engage with divisions and regions nationwide.
- The Operating Model implementation continues nationwide, with Garda Staff at all grades being allocated to divisional functional areas as staff become available from recruitment streams.
- Commissioning a Workforce Strategy in early 2024: The Strategic Workforce Plan is currently
 in progress. Forecasting and planning the supply and demand of resources and business
 requirements is an ongoing exercise.
- Business Case Validation Framework: The Business Case Validation Framework continues to
 assist in the efficient assessment of business cases from several areas. The framework has
 been trialled with the Finance, Internal Audit, Legal and Occupational Health sections, and the
 Strategic Transformation Office.

- Clearing House: The next Clearing House Meeting with the Department of Justice, the Policing Authority and the Department of Public Expenditure, NDP Delivery and Reform will take place in March 2024.
- Demand Meeting: The next Demand Meeting will be held in March 2024.
- Workforce Planning Reports: The Q4 quarterly report is in progress and due to be submitted imminently. The Workforce Planning Annual Report and the report on the Horizon Scan are also in progress, and nearing completion.

Resourcing

- There are currently 24 Garda Staff internal and open recruitment competitions in progress across the organisation.
- Clerical Officer Competition:
 - Offers to candidates are ongoing.
 - Batch 2 interviews were held from 29 January 2024 to 16 February 2024 for nine (9) counties.
 - Final panels are being approved and issuing of results is ongoing.
 - Batch 3 interviews commenced on 26 February 2024 and are ongoing for a period of 2.5 weeks for Dublin, Cork, Meath, Westmeath, Tipperary and Louth.
- Executive Officer competition: Final interviews commenced on 21 and 22 February 2024, and a final panel is now being collated.
- Assistant Principal Officer competition 2022: There are three candidates remaining on the panel. One candidate commenced on 6 February 2024.
- Assistant Principal Officer competition 2024: Competition preparation is ongoing.
- Fleet Support Officer: Four candidates were offered positions and accepted. The fourth candidate commenced on 26 February 2024.
- Professional Accountant grade 2: Two candidates have entered vetting with one candidate due to commence in May 2024.
- Occupational Health Physician: Two candidates were offered positions and accepted, with the first candidate due to commence in early March 2024 and the second candidate due to commence in late April 2024.
- Higher Executive Officer: A panel is in place.
- Principal Officer Finance: A third candidate was offered a position and accepted. Appointed by the Policing Authority effective on 29 February 2024.

Garda Appointments/Recruitment

- 838 trainees have commenced in the Garda College since the 2022 and 2023 Garda Trainee Competitions closed:
 - 92 in November 2022
 - 135 in February 2023
 - 154 in May 2023
 - 174 in July 2023
 - 174 in October 2023
 - 109 in December 2023
- 220 candidates have cleared all elements of the process and will be invited to the next intake. Invitations to candidates will issue 4/5 weeks prior to the next intake.
- The next intake is scheduled for 8 April 2024.
- 1,055 candidates (inclusive of the 136 who have cleared all elements so far) are still in the An Garda Síochána clearance process. Of these, 292 are from the 2022 competition and 763 from the 2023 competition.

- The 2024 Garda Trainee recruitment competition closed on 8 February 2024. 6,382 applications were received. Almost 40% of applications were from candidates aged 35 years or over.
- Ongoing Garda member competitions: There are currently 29 national, 5 regional, 1 overseas and 43 divisional member competitions underway.

Garda Trainee Recruitment Outreach

- The Garda Trainee recruitment campaign 2024 closed on 8 February 2024 and was supported by colleagues nationally in terms of outreach activities, including but not limited to:
 - Recruitment stands in public areas, including shopping centres and sports clubs.
 - Visits to second and third level educational institutions.
 - Interviews on radio and in the print media.
 - Engagement with diverse communities.
 - Social media posts promoting a career in An Garda Síochána.
- Outreach was aided by the provision of materials to each division nationally i.e. English and Irish leaflets and posters. Information was made available via the Garda.ie website in multiple additional languages.

Irish Language Activity

- To raise awareness of the Irish language stream in the recruiting process, Human Resources and People Development engaged with Gaeltacht Language Planning Officers, held events in Gaeltachtaí and used online platforms such as Peig.ie.
- The recruitment campaign was supported with leaflets and posters 'as Gaeilge' and colleagues participated in interviews on Irish radio, to encourage Irish speakers to consider a career in An Garda Síochána.
- A European Certificate in Irish online classes for Garda personnel commenced in February 2024 and will conclude with personnel undergoing the Teastas Eorpach na Gaeilge (TEG) examinations in June 2024.



3. Information and Communications Technology

In 2024, ICT will continue to progress the delivery of key projects in line with An Garda Síochána strategic goals and in line with our Data and Technology Vision on 'Information-Led Policing'. We will also continue to support and enhance the operational needs of the organisation in the office, on the frontline and working remotely, by enabling An Garda Síochána personnel to access Garda information systems in a secure manner where needed, particularly in the use of digital collaboration tools for desktop and mobile.

ICT Capacity

ICT is continuing the advancement in relation to the recruitment of over 100 approved posts for ICT. An agency has been awarded the contract and meetings are being held between ICT, Human Resources and the selected agency, to develop a process for the direct recruitment competitions. The first campaign run by the recruitment agency went live in February 2024 for Digital and ICT Managers at the grade of Assistant Principal. The closing date for this competition is 6 March 2024. In addition, a promotional video has been recorded in conjunction with An Garda Síochána Corporate Communications section which, once finalised, will be utilised in the upcoming ICT recruitment campaign.

GardaSAFE - The new Garda Computer Aided Dispatch (CAD) System

As reported last month, the GardaSAFE (CAD) system, for managing calls for service from the public, is now live across all regions within An Garda Síochána. The new system replaces the former CAD system with a modern system. A new release across the GardaSAFE system is due to be deployed in early March 2024 and if successful, client upgrades will follow. The system remains in a stabilisation period with enhanced support from ICT and the external supplier. Planning for Phase 2 of the GardaSAFE project has commenced, which will introduce enhancements to the system.


Body Worn Cameras (BWC) and Digital Evidence Management (DEMS)

Body-worn cameras (BWCs) are to be introduced in An Garda Síochána in the future, in line with our Digital Strategy and the Commission on the Future of Policing in Ireland report. It will require significant capital investment for the appropriate ICT infrastructure. The procurement process for a limited proof of concept (POC) has commenced. An Garda Síochána published a request for tender (RFT) on EU Tenders website in February 2024. The RFT invites companies to tender for the provision of BWC and a limited form of the DEMS for An Garda Síochána to conduct the POC. Responses have been received to the RFT and the evaluation process is underway. It is hoped that this will be completed in mid-March 2024.

Mobile App Development – Vehicle Insurance

A new app has been developed which integrates with data provided by the vehicle insurance industry to retrieve real-time insurance status of vehicles from a mobile app. The app was deployed to all member devices on 27 February 2024. The availability of vehicle insurance details provides a valuable tool for frontline members in improving road safety for everyone. The number of vehicles seized for

non-compliance with insurance obligations has increased significantly in areas where the app has been deployed. While only private insurance policies are included at the moment, fleet policy data is scheduled to be added later in the year, when it has been provided to An Garda Síochána by the insurance companies. Also in February 2024, An Garda Síochána, through its various social media platforms, released a short video showcasing improvements in technology through the Garda mobility app, which allows access to real time information at the roadside. Such technology improvements are in line with ICT's delivery of information-led policing.

Roster and Duty Management System (RDMS) Deployment

As reported previously, RDMS is being deployed on an incremental basis to An Garda Síochána divisions and a number of specialist sections, in accordance with local readiness to adopt same. RDMS went live in February 2024 in the following areas:

- Liaison and Protection
- Garda National Roads Policing and Community Engagement Bureau
- Finance Procurement

In March 2024, it is scheduled to be deployed to the following areas:

- Office of the Commissioner
- Office of Deputy Commissioner, Strategy Governance and Performance
- Office of Deputy Commissioner, Policing and Security
- Corporate Services
- Garda Band
- Eastern Regional Office
- Southern Regional Office

There remains a very small number of specialist units yet to receive RDMS and these are planned for rollout by the end of Q1 2024.

Investigation Management System (IMS) Deployment

Investigation Management System (IMS) rollout is continuing, with the Kildare Division due to go live at the end of March 2024. With each rollout, additional hardware is also being installed to support key users. Engagement is commencing with the Laois/Offaly Division for a planned rollout by the end of June 2024. Early stage planning is beginning for the proposed start of the rollout to the North Western Region. In addition, the IMS App is currently being trialled by a cohort of more than 30 users in a live operational setting, and feedback will be used to guide future actions and deployments.

Mobile Device Deployment

To date, almost 15,600 mobile devices have been deployed to frontline policing members. Deployments to DMR East are currently underway. As highlighted previously, commitment to ongoing and sustained investment is required to support devices that have been deployed, including significant software licence renewal costs, investment in backend infrastructure and routine replacement of end-of-life devices. Planning has begun with the vendor regarding the process for device refreshes throughout 2024.

ICT Workstream to enable and support the new Garda Operating Model

The Operating Model was successfully delivered to the DMR North Central Division at the end of February 2024, supported by ICT changes to core information systems. The Operating Model activation for the Wexford/Wicklow and DMR North Divisions is on track and scheduled to take place on 24 March 2024. Planning discussions are continuing for further deployments throughout 2024.

4. Corporate Communications

Throughout the month of February 2024, the Office of Corporate Communications continued to communicate internally and externally on a broad range of policing activities undertaken by An Garda Síochána nationwide, in our mission to keep people safe.

The Office of Corporate Communications supported a number of high level communications and campaigns, including the "It's a job worth doing" recruitment campaign, which concluded this month, yielding over 6,380 applications. This competition was the first ever which invited applications from those up to 50 years of age. Interestingly, of those who applied, almost 40% fell into the 35-49 age bracket.

Supporting this campaign, this office conducted a media day in the Garda College in Templemore aimed at highlighting the requirements of the Garda fitness test. This innovative initiative saw members of the media undertake the test. Further to this, testimonials of current Garda members in various roles were shared on social media. These detailed why they wanted to become members of An Garda Síochána and offered words of encouragement to those contemplating joining.

In addition to holding a number of media briefings detailed herein, the Office of Corporate Communications continued to promote the good police work, which is ongoing across the country. This included social media posts highlighting the efforts of Probationer Gardaí, Garda Callum Hegarty and Garda Thomas Hayes, who were called upon to assist in a medical emergency while on beat patrol. Together with Trainee Garda Joe Stubbings, they took turns performing CPR while further medical help was sought and the person received necessary treatment.

Work was also undertaken by this office to promote key drug seizures which took place this month, including the seizure of 546kg of a suspected synthetic, illegal drug, with an estimated street value here in Ireland of over €30m on 16 February 2024. This formed part of a joint operation with Revenue at Cork Port, and subsequently resulted in arrests and the seizure of two firearms. Further seizures highlighted included a seizure of approximately €3m worth of suspected drugs by the Garda National Drugs and Organised Crime Bureau, which also led to a number of arrests.

Media Briefings: Commissioner attends Tullamore schools' road safety campaign 26 February 2024

Commissioner Harris attended an event at Tullamore Rotary Club, supporting a road safety campaign being led by Tullamore National Schools; Scoil Naomh Brighde Buachaillí and Scoil Mhuire, entitled "Phone down, safe driving". This office held a media briefing following the event facilitated by Commissioner Harris, which served to highlight road safety advice.





Cross-Border Police Conference on 27 and 28 February 2024

As part of the 2024 Cross-Border Police Conference on Organised and Serious Crime, which took place on 27 and 28 February 2024, this office hosted a media briefing with Commissioner Harris and Chief Constable Boutcher of the Police Service of Northern Ireland. The event was also attended by Minister for Justice, Helen Mc Entee, who similarly facilitated media. The theme of the conference was on 'Current Trends and Emerging Risks', and explored topics such as; 'Emerging Drug Trends on the island of Ireland'; 'The increasing use of Crypto-Assets by Irish OCGs'; 'The impact of Transnational Economic Organised Crime in the Irish context'; 'Threats and Trends in Human Trafficking and Immigration'; and the Joint Agency Task Force.



Renewed Appeal for Missing Person Jon Jonsson on 9 February 2024

The Office of Corporate Communications held a media briefing at Ballymun Garda Station on 9 February 2024 to issue a renewed appeal for information in connection with missing person Jon Jonsson. The appeal which marked the fifth anniversary of Jon's disappearance was facilitated by Superintendent Darren McCarthy and by members of Jon's family. The purpose of the briefing was to illicit information from the public following the disappearance of Jon, an Icelandic man in his early 40s, who went missing on 9 February 2019 in Dublin. During the briefing, media were given details of Jon's last known movements and members of his family urged anyone with information to come forward.





Garda Recruitment: Media Event on 6 February 2024 the the Garda College, Templemore – Can you pass the pre-entry fitness test?

In support of the 'It's a Job Worth Doing' recruitment campaign, this office held a media briefing in the Garda College in Templemore, highlighting the various stages involved in the application and recruitment process. During this event members of the media were invited to attempt the pre-entry Garda fitness test, which makes up the third stage of the recruitment process. Video content from throughout the day was shared on social media. Following the event, journalists reported their first hand experiences, with reports featuring in the following outlets: RTÉ the Six One News; Virgin Media One; TG4; RTÉ Radio One; The Irish Times; The Irish Independent; The Journal; Irish Mirror; Beat 102; Newstalk; Daily Mirror; The Irish Examiner; The Herald; Irish Daily Star; The Belfast Telegraph; Tipperary Star and Nationalist; Kildare Now; Longford Leader; The Echo; Limerick Leader; Offaly Express; Carlow Nationalist; Roscommon Herald; Western People; Laois Nationalist; BreakingNews.ie; Leinster Express; Kilkenny People; and Dundalk Democrat. Irrespective of whether they passed or missed the passing grade, all generally accepted that with the right preparation it was possible to pass the fitness test and it should not deter those considering a career in An Garda Síochána.





Road Safety Reimagined; St. Brigid's Day Bank Holiday Road Safety Campaign; and our first National Slow Down Day of 2024

A number of road safety initiatives were promoted by the Office of Corporate Communications during the month of February 2024. These included the holding of a media briefing for the St. Brigid's Day bank holiday weekend on 1 February 2024 at the University of Limerick (UL). At this event, UL business students involved in a collaborative road safety project between UL, An Garda Síochána and Limerick City and County Council, discussed how they would reimagine road safety with media. Among the contemporary marketing solutions that they developed to positively affect young driver behaviour were projects titled: 'One high can lead to a six-foot low' and 'Comparing the road to the pitch'. A video was compiled by this office and shared on our channels to promote the event. Further to this, media were invited to attend separate briefings as part of the St. Brigid's Day bank holiday road safety enforcement operation on 4 February 2024 at the R192, Drumbrade, Cootehill, Co. Cavan and on 5 February 2024 at the N76 Parkmore, Callan Road, Kilkenny. Updates were provided in respect of detections by way of press release and also via social media activity. Similar activities were planned and took place for National Slow Down Day on 29 February 2024.

Garda Press Office Activity

The Garda Press Office operates 7am-11pm seven days a week, responding to hundreds of queries, coordinating external communications and media relations, and regularly updating our social media platforms. Further to those already outlined, this month's activity included:



During February 2024, An Garda Síochána internal communications team delivered eight comprehensive Newsbeat updates. Readership remained consistently strong, hovering around approximately 60% throughout the month. Key highlights from regular Newsbeat updates include:

- Publicising the return of An Garda Síochána initiative 'Go Purple Day' on 3 May 2024, which will help raise awareness of domestic violence and the supports available to those affected in Ireland.
- Update issued on body-worn cameras; a request for tender for body-worn cameras and Digital Evidence Management Systems (DEMS) has now been made to the EU Tenders website.
- Information on the latest Garda recruitment campaign, which received approximately 6,380 applications. It follows a previous recruitment campaign which attracted approximately 5,000 applications 10 months ago.
- Article emphasising the importance of prioritising mental health and availing of organisational supports available to all personnel.
- Information on the increased strength incapacitant spray to be delivered to all frontline Gardaí this month.





Garda Portal

The Garda Portal and digital signage received ongoing content updates. These digital displays, including screensavers and portal banners, were visible on desktops across the organisation. Notable updates provided to personnel during this period were information on the anti-corruption reporting line. Key updates delivered to personnel included:

- 1. Health and safety information regarding cell inspections.
- 2. Details on contacting Crimecall.
- 3. Information on Operation Limelight.



Social Media Activities

The Office of Corporate Communications oversees five official social media channels for An Garda Síochána: Facebook, Instagram, TikTok, LindkedIn and X (formerly Twitter). These channels are used to promote activity within the organisation, highlighting the good work that is being done nationwide. They are also used to provide key communications to the public on behalf of An Garda Síochána. These communications may include public information regarding traffic disruption, public appeals for information, alerts i.e. CRI alerts and campaigns. The Office of Corporate Communications measure the success of these communications by capturing:

- 1. The number of followers/individual users who have subscribed to each account.
- 2. The rate of engagement with the account. A high percentage indicates we are producing compelling posts that resonate with our audience. Typically, a good engagement rate is in the region of 1-5%.
- 3. The number of engagements with the content / posts we produce.


Update on TikTok

Since the start of the year, the Office of Corporate Communication has been growing a following on An Garda Síochána newest social media platform, TikTok. This has enabled the organisation to direct key messaging towards a younger demographic, not being captured in great volumes through some of the existing social media networks. The channel currently has 14,562 followers with a high engagement rate at 16.3%. This engagement has largely been driven by seven videos (six in English and one in Irish) posted to the platform in recent weeks. These have had a focus on delivering key road safety messages and advice. These videos collectively have had 2.1 million views to date and a reach of 1.6 million. Statistics from this month show that more than 62% of those who are engaging with our TikTok account are between 18 and 35 years of age. Meanwhile our overall engagement is made up of 58% men and 42% women. This channel will continue being utilised to share planned video content, together with other key corporate messaging.



5. Implementation of Cultural Change

Culture Reform Programme

- Leading Ireland's Future Together (LIFT) was launched in 2018 and is a social enterprise initiative
 aimed at increasing the level of positive leadership in Ireland. Deputy Commissioner Strategy,
 Governance and Performance has approved in principle a four month pilot partnership
 programme between An Garda Síochána and LIFT. Consultations are currently ongoing with the
 Director of Training in the Garda College towards the pilot's integration with existing leadership
 development programmes.
- An implementation plan stemming from the last Culture Audit has been approved in principle by the Senior Leadership Team on 25 January 2024. The Garda Ethics and Culture Bureau have liaised with the stakeholders for each initiative. A meeting is to be scheduled with Assistant Commissioner, Governance and Accountability, the Garda Ethics and Culture Bureau, Employee Relations, and representatives from the Unions and Associations, to discuss the Culture Audit Implementation Plan. The date for this meeting is to be confirmed.

Enhancing Professional Conduct

- Edition five of 'Learning the Lessons' will be published on Newsbeat in Q1 2024. The title for this edition will be 'Abuse of Power for Sexual Gain'. The Lessons Learned Working Group met twice in February 2024 in order to discuss the structure for the fifth edition this year. Cases for this edition were discussed and certain examples were confirmed as being suitable for inclusion. The working group will meet on 5 March 2024 in order to finalise the document.
- Arising from the Professional Conduct Steering Group, the Key Risk Action Plan for the Garda Ethics and Culture Bureau was forwarded to senior management on 28 February 2024.

6. Risk Management

- An Garda Síochána Corporate Risk Register captures 10 principal risks currently facing the
 organisation. An Garda Síochána corporate risks are being managed effectively by their assigned
 corporate risk owners, overseen by the Chief Risk Officer, Risk and Policy Committee, and
 supported by the Garda Risk Management Unit (GRMU).
- The last meeting of the Risk and Policy Committee took place on 28 November 2023. The next meeting is scheduled to take place on 19 March 2024.
- Following extensive collaboration, GRMU have assisted the assigned risk owner, Executive Director, Strategy and Transformation, in the development of a dedicated corporate risk in respect of the potential impact of the Policing, Security and Community Safety Act, 2024, on the organisation. This corporate risk is proposed for consideration of inclusion on the Corporate Risk Register at the next meeting of the Risk and Policy Committee.

During the month of February 2024, the Garda Risk Management Unit (GRMU);

- Held one-to-one meetings with all corporate risk owners/support staff, to assist in the review and update of their risk registers.
- Issued a 'Risk Champion Network' bulletin.
- Made significant progress in relation to the 'e-Risk' ICT system. GRMU continue to provide assistance to ensure the timely delivery of the new system. On 22 February 2024, phase 1 of the 'e-Risk' system (local risk) went live to the organisation, commencing on a pilot basis in the DMR. GRMU has conducted 'e-Risk' briefings and system familiarisation across the DMR on the following dates:
 - o DMR: 14 February 2024,
 - o DMR West: 19 February 2024,
 - o DMR North Central: 20 February 2024,
 - o DMR South Central: 20 February 2024,
 - o DMR North: 26 February 2024,
 - o DMR South & East: 29 February 2024,
 - o DMR Roads Policing: To be scheduled in March 2024.
 - o DMR North: 26 February 2024,
 - o DMR South & East: 29 February 2024,
 - DMR Roads Policing: To be scheduled in March 2024.
- Anticipated that an incremental nationwide rollout of phase 1 of the 'e-Risk' system will
 commence following a successful pilot in the DMR. Phase 2 (corporate risk) development is
 currently being scoped out by GRMU and ICT, following learnings from the implementation of
 phase 1.
- Superintendent GRMU provided risk management training to the personnel of the Garda College.
- Superintendent GRMU provided a risk management presentation at a DMR governance masterclass/workshop.
- Superintendent GRMU conducted a risk register development workshop with personnel of the Waterford/Kilkenny/Carlow Division. GRMU continue to provide support and guidance to risk managers and support staff via Microsoft Teams, teleconferencing, phone, email and face-to-face meetings.

7. Data Quality and Operational Value of Data

Data Update

- A further two data culture workshop sessions took place in February 2024, with a number of strategic objectives agreed in principle to promote good quality data within the organisation.
- The Garda Information Services Centre (GISC) delivered a training webinar on the Performance and Accountability Framework (PAF) on 13 February 2024, focusing on incident outcomes.
- Refresher training for GISC staff commenced in February 2024, covering the issues of PEMS and youth referrals on PULSE.

Garda National Vetting Bureau Update

- For February 2024, Garda standard vetting average turnaround times continue at their long-term figure of 5-6 working days once an application is received.
- 108,051 Garda vetting applications received to the end of February 2024.
- 17.9% year on year increase on vetting applications received to the end of February 2024.

Compliance

1,435 role relevancy checks were carried out by our Compliance Team in February 2024, leading
to five vetting applications being rejected as they did not meet the criteria of relevant work or
activities as set out in Schedule 1 of the National Vetting Bureau (Children and Vulnerable Persons)
Acts 2012 to 2016.

European Criminal Records Information System (ECRIS)

 In February 2024, the European Criminal Records Information System (ECRIS) section of the Garda National Vetting Bureau processed 86 requests from operational Garda members, for criminal record information in respect of nationals of EU member states who are being investigated or prosecuted by An Garda Síochána. This criminal record information is significant in the successful investigation and prosecution of individuals here, and also allows courts to make more informed sentencing decisions.

Crime Trends

GSAS closely monitors crime trends, and disseminates analysis on a regional and divisional basis. This feeds directly into planning operational activities aimed at reducing and preventing crime. Crime incident figures and the associated trends are based on provisional data, and are subject to change following review. The CSO publications represent the official crime statistics. These are carried in the CSO's quarterly publications of crime trends and in their annual reports.

COVID-19: Between 12 March 2020 and 22 January 2022, government measures to inhibit the transmission of coronavirus had been in place, including, at various times throughout the pandemic, ceased operation of non-essential services and prohibition of non-essential travel. There were reductions in most crime groups during this period. Upward trends since that time indicate a return to more typical pre-COVID levels.

The following pages present trends for reported property crime, crimes against the person, sexual offences, criminal damage and public order offences, in terms of incidents reported per month and the 12-month average. The 12-month average represents the average incidents reported per month over the 12 months up to and including the month of measurement (e.g. 12 month average for April 2022 = average per month for the period May 2021 - April 2022).



8. Policing Successes

Throughout the month of February 2024, there have been numerous incidents of outstanding police work performed by members of An Garda Síochána in the course of their routine operational policing duties, supported by specialist personnel from national units. A synopsis of some of those incidents that occurred during the month of February 2024 is set out hereunder.

On 3 February 2024, as part of an ongoing intelligence-led investigation, Gardaí conducted a coordinated search of a residential premises, during which a 9mm Semi-Automatic handgun, 13 rounds of 9mm ammunition and a silencer were seized. One suspect was arrested and subsequently charged with possession of a firearm and remanded in custody.

On 6 February 2024, a suspect appeared before the courts charged with a range of offences following a two year investigation by the Organised Prostitution Investigation Unit and other units within the Garda National Protective Services Bureau. In total, the suspect has been charged with over 100 offences, including one alleging contravention of Section 72 of the Criminal Justice Act 2006 in relation to Organised Crime, as well as offences under the Criminal Law (Sexual Offences) Act 1993 and the Criminal Justice (Money Laundering and Terrorist Financing) Act 2010. The Organised Crime charge represents the first occasion that a charge for this type of offence was directed in the specific context of a prostitution investigation. The suspect was remanded in custody.

On 7 February 2024, members from the Extradition Unit at the Garda National Bureau of Criminal Investigation, extradited a suspect sought for murder and arson, from the UK to Ireland. This suspect was arrested in the UK on 31 January 2024 on foot of an Irish requested Trade and Cooperation Agreement (TCA) warrant, which had been endorsed at the High Court on 11 December 2023. On return, this suspect was arrested by the investigating member and was brought before the District Court on 8 February 2024, where they were charged and remanded in custody.

Also on 7 February 2024, following identification of a suspected unlawful entrant and accompanying facilitator by the Border Management Unit in Dublin Airport, personnel attached to the Garda National Immigration Bureau, detained an individual under the provisions of Section 4 of the Criminal Justice Act, 1984. The alleged facilitator was subsequently charged with an offence under Section 6 (1) of the Criminal Justice (Smuggling of Persons) Act, 2021, for smuggling a Syrian national into the State. The alleged facilitator was remanded in custody awaiting the DPPs directions and the Syrian national was refused leave to land.

On 16 February 2024, as part of a multi-jurisdictional investigation, members of An Garda Síochána including the Garda National Drugs and Organised Crime Bureau, the Garda National Bureau of Criminal Investigation, and the Revenue and Customs Services, effected a controlled delivery in Cork Port, during which approximately €32m worth of suspected MDMA was located and seized. Two suspects were arrested, detained and subsequently charged under Section 15A of the Misuse of Drugs Act, 1977, as amended. One suspect was also charged under Section 15B of the Misuse of Drugs Act, 1977, as amended. Both suspects were remanded in custody and investigation files are being prepared for the consideration of the DPP.

On 17 February 2024, Gardaí responded to reports of an unresponsive person. The members at the scene performed a number of response tests and determined that the person had lost consciousness. They called for urgent assistance from emergency services. Two Gardaí began CPR, while the third

member went in search of a defibrillator. Dublin Fire Brigade arrived shortly after this and conveyed the person to hospital, where they received further medical attention. The individual continues to make a full recovery, following the prompt actions of the responding Gardaí.

On 22 February 2024, as part of an ongoing intelligence-led operation targeting an organised crime group involved in the importation and onward distribution of controlled drugs into the State, personnel attached to the Garda National Drugs and Organised Crime Bureau carried out a coordinated and controlled stop of two vehicles. 100Kg of suspected cannabis herb worth an estimated street value of €2,000,000 was recovered in one vehicle. Follow up searches were then conducted on a number of identified premises, during which 3kg of suspected ketamine, 12kg of suspected MDMA, 10kg of suspected cannabis herb, 626g of suspected amphetamine, 10,000 suspected ecstasy tablets, and assorted suspected cannabis edibles and vapes were recovered. The total estimated street value of suspected drugs seized was €3,250,000. Three suspects were arrested under the provisions of the Misuse of Drugs Act and detained under Section 2 of the Criminal Justice (Drug Trafficking Act), 1996. They were subsequently charged with offences contrary to Section 3 and 15 of the Misuse of Drugs Act.

On 27 and 28 February 2024, Criminal Profilers from the Royal Canadian Mounted Police (RCMP) visited the Garda National Bureau of Criminal Investigation (GNBCI) in Walter Scott House. The Criminal Profilers have more than 30 years' experience between them in investigating serious and serial offending, including homicide and sexual crime. Their briefings focussed on a Persons of Interest Priority Assessment Tool, and concepts of geographic profiling and the geography of crime which are particularly relevant to the work of GNBCI. Continued engagement is envisaged between the RCMP with regard to these and other areas of crime investigation.

Also on 27 and 28 February 2024, the Cross-Border Police Conference on Organised and Serious Crime took place. The theme of this year's conference was 'Current Trends and Emerging Risks'. Topics explored during the conference included emerging drug trends on the island of Ireland, the increasing use of crypto-assets by Irish organised crime groups, the impact of transnational economic organised crime in the Irish context, threats and trends in human trafficking and immigration, and the Joint Agency Task Force.

On 29 February 2024, whilst on mobile patrol, members attached to a Roads Policing Unit observed a car driving dangerously. Roadside checks ascertained that the vehicle was the subject of an unauthorised taking earlier that day. The vehicle attempted to evade Gardaí and following a lengthy pursuit, Gardaí apprehended and arrested the suspects. The driver was arrested for dangerous driving and was questioned in relation to a number of other crime incidents in the area, including burglary and a threat to kill. They were subsequently charged with dangerous driving offences and brought before the courts, where they were remanded in custody.

Also on 29 February 2024, Gardaí became aware of a video circulating where a suspect recorded themselves making threats about other individuals, whilst in possession of two firearms. The suspect's location was identified and Gardaí immediately attended the scene. An Operational Commander was assigned and the Garda Emergency Response Unit, local Armed Support Units, and national and local negotiators attended the scene. A cordon was established and the suspect was directed to exit the location by members of the Emergency Response Unit and was subsequently arrested. Two firearms were recovered inside the location and a further two firearms were subsequently recovered close to the address. The suspect has appeared before the courts in connection with this incident.

During the month of February 2024, Operation Sonnet checkpoints were carried out by personnel attached to the Garda National Immigration Bureau on the M1 motorway at the border with Northern Ireland on four separate days. A total of 47 buses travelling southbound to Dublin were stopped and immigration checks carried out in respect of all passengers on board. From the 47 buses, a total of 25 persons were detected entering the State illegally, without the relevant visas or travel documents. All were subsequently refused leave to land and returned to the UK by ferry to Holyhead (19) and train to Belfast (6).

9. Community Engagement and Organisational Initiatives

St. Brigid's Day Bank Holiday Weekend Road Safety Operation

From 1–6 February 2024, An Garda Síochána implemented a national roads policing plan for the St. Brigid's Day bank holiday weekend. The plan had members conduct high visibility patrols with a focus on the enforcement of lifesaver offences; speeding, holding a mobile phone while driving, seatbelt use and driving while intoxicated. Over the course of the operation, there were in excess of 900 mandatory intoxicant testing checkpoints conducted, over 160 persons detected driving under the influence of alcohol and/or drugs, over 230 detections for using a mobile phone, over 60 detections for seatbelt offences and almost 3,000 speeding offences detected.



The Bi-annual National Metal Theft Forums

On 8 February 2024, the first of the bi-annual National Metal Theft Forums took place. The National Metal Theft Forum is embedded in the Crime Prevention and Reduction Strategy 2021-2024. A number of presentations took place touching on topics such as crime statistics, metal theft and crime prevention. This forum provides An Garda Síochána an opportunity to hear from those involved in the metal industry, i.e. communications providers, recycling facilities, scrap metal facilities. It also allows them to ask Gardaí questions in an open forum regarding metal theft, as well as crime prevention and prosecution.

Office for Democratic Institutions and Human Rights Webinar

On 13 February 2024, the Garda National Diversity Unit attended an Office for Democratic Institutions and Human Rights webinar in the "Under the Spotlight" series devoted to promoting better support for hate crime victims with learning disabilities and/or autism. During the online session, the

#ImWithSam hate crime campaign was presented. Topics included tackling hate crime at its roots and a demonstration of practical ways to offer better support for victims. The campaign represents the 73% of people with a learning disability and/or autism who have experienced hate crime; people who have been subjected to physical attacks, sexual assault and emotional manipulation because of their disability.

Heroes Rock event in Limerick

On 16 February 2024, members attached to Henry Street Garda Station organised and hosted an event at Dolans Warehouse, Limerick. The "Heroes Rock" event was organised in aid of the Little Blue Heroes and a host of Ireland's most talented musicians rocked Dolans. The ticketed event was a great success with an excellent turn out. All proceeds went to the Little Blue Heroes charity.

The Youth Justice Gaisce Awards

On 27 February 2024, members attached to the Garda National Youth Diversion Bureau attended the Youth Justice Gaisce Awards at the Department of Justice Atrium, St. Stephens Green. The event was opened by Mr. James Browne T.D., Minister of State at the Department of Justice. Members from the Garda Youth Diversion Bureau spoke on the day. Young people involved in KEEP, Bru, Clay and Smart, all of which are Youth Diversion Projects, were awarded with Silver and Bronze Gaisce Awards to acknowledge the pro-social activities they have engaged in and the consequent personal development they have achieved.

The First National Slow Down Day of 2024

On 29 February 2024, An Garda Síochána, the Road Safety Authority and Transport Infrastructure Ireland, ran the first National Slow Down Day of 2024 for a 24-hour period. During the course of the operation, divisional roads policing members, supported by their colleagues and mobile safety camera vans, carried out speed checkpoints nationwide. GoSafe, the current service provider for our mobile safety cameras, have reported that during the 24-hour period, they checked the speed of 218,575 vehicles and detected 423 vehicles travelling in excess of the applicable speed limit. Early detection figures show that there were 479 drivers detected speeding by Garda member interceptions, bringing the total number of detections to 902 for the day of action*.

Security and Safety briefings provided by the Garda National Crime Prevention Bureau

Throughout the month of February 2024, the Garda National Crime Prevention Bureau provided security and safety briefings to a number of external organisations, such as Virgin Media, the HSE, Inditex and Deliveroo.

10. Operating Model

Business Services and Performance Assurance Functional Areas

Following successful deployment of the Operating Model into the DMR North Central Division on 25 February 2024, 12 divisions have now fully commenced the four functional area structures (Business Services, Performance Assurance, Crime and Community Engagement). The Operating Model Central Implementation Team continues to monitor, liaise, support and engage with the 12 divisions concerned following implementation, in an effort to provide organisational support to the respective divisional management teams in managing the transitional and post-implementation phases.

- Progress continues with Business Services Functional Area (BSFA) and Performance Assurance
 Functional Area (PAFA) implementation across the remaining nine divisions, with preparation
 continuing to transition the Wexford/Wicklow Division to the Operating Model structure on 24
 March 2024.
- 21 divisions have commenced implementation of BSFAs. They are receiving continual support from the Operating Model Team.
- Chief Superintendents have been appointed to the two new divisions of Kildare and Donegal, following on from the 2023 Operating Model Review.
- The implementation of PAFA standardised processes in the 12 fully commenced Operating Model divisions is ongoing. In addition, Superintendents have been assigned to PAFAs in the DMR West, DMR East, DMR North, Laois/Offaly, Kildare and Wexford/Wicklow Divisions. They have commenced utilising Performance Assurance standardised processes and are at various stages of implementation within these divisions.

The Regional Office

• Regional Office phased implementation commenced on 12 June 2023 in the Southern Region with wave 1, which relates to Performance Assurance. This involves the alignment of the Regional Office standardised processes with the Functional Areas in their divisions. Commencement of waves 2, 3 and 4 is on hold due to divisional office process re-alignments (seven processes), which took place in the Southern Region. This concluded in December 2023, and following review and analysis of feedback, the rollout will continue with waves 2, 3 and 4.

Crime and Community Engagement Functional Areas

The following 12 divisions are operating in the four Functional Area structure.

i. Cork City vii. DMR South,

ii. Kerry DMR South Central, viii. iii. Galway Clare/Tipperary ix. Limerick Meath/Westmeath i۷. х. ٧. Mayo/Roscommon/Longford xi. Louth/Cavan/Monaghan Waterford/Kilkenny/Carlow **DMR North Central** vi. xii

These 12 divisions have commenced their Community Engagement and Crime Functional Areas as follows:

- Garda personnel formally aligned to one of the four Functional Areas in the division.
- Each Garda station aligned to a Community Engagement Functional Area within the division.
- PULSE 7.8 deployed to embed and align PULSE with the Operating Model Functional Area structures.

Current Status

Planning and implementation preparation is underway for the continued rollout of the remaining divisions in 2024, allowing for the alignment of other transformation projects, including the Roster and Duty Management System (RDMS), CAD 2 and the Investigation Management System (IMS). Each division that has not already introduced PULSE 7.8 has been provided with a tailored divisional implementation plan. The implementation plan has been developed to provide an incremental approach and step-by-step guide to implementing the Operating Model in the remaining nine divisions. The plan is designed to assist each Divisional Officer to manage and track key deliverables required to transition to new Operating Model structures. Process development work for Community Engagement and Crime standardised processes is still underway, with significant progress made to date.

Garda National Crime and Security Intelligence Service (GNCSIS)

A formal working group has been set up to include personnel from the Operating Model Team and the Garda National Crime and Security Intelligence Service (GNCSIS), to commence the design process of a blueprint for a Regional Business Services Functional Area at GNCSIS.

Current Emerging Issues

• There are five divisions where accommodation works are required. This is having an impact on the implementation of areas such as Business Services in these divisions.
