## Re: Freedom of Information Request FOI-000311-2020 Request Part-Granted

#### Dear

I refer to your request, dated 4<sup>th</sup> September, 2020 and received on 7<sup>th</sup> September, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

*Under the FOI Act, 2014, I wish to request the following records:* 

- How much An Garda Siochana earned in the first six months of 2020 from policing events; and a breakdown of the events and costs.
- How much An Garda Siochana earned from policing events for each of the years 2017, 2018 and 2019; please provide a breakdown of events and cost.

I wish to inform you that I have decided to part-grant your request on the 25th September, 2020.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision

On receipt your request was forwarded to the Finance Section of An Garda Síochána who have provided this office with the attached table which provides details of the requested information for the year 2020 to date.

I am refusing the second part of your request in respect of the years 2017, 2018 and 2019, in accordance with Section 15(1)(d) of the FOI Act (2014) which states:

#### Refusal on administrative grounds to grant FOI requests

15(1) A head to whom an FOI request is made may refuse to grant the request where (d) the information is already in the public domain

Information in respect of Non Public Duty payments to An Garda Síochána for the years 2017, 2018 and 2019 were the subject of a previous FOI request (FOI-0000015-2020) as is the policy for An Garda Síochaná all non-personal FOI requests that result in the release of records are published on the FOI decision log on the Garda website.
