Dear

I refer to your request, dated and received on 29th December, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I wish to make a Freedom of Information request under the Freedom of Information Act 2014.

I wish to know the total costs, which can be made available to me under Schedule 1 Part 1 (n) of the FOI Act 2014, associated with members of the Garda Síochána who issued fines to people who did not wear face masks.

Specifically I only want fines that were issued in the DMR (for public transport purposes where the location on the fine was within the DMR) (but this FOI request encompasses public transport and any incident to happen within the DMR).

Date Range: Since the legislation on fines (What I presume to be the ϵ 80 fine) was introduced in 2020 up to the 31st of December 2021.

Any additional information as regards the non wearing of face masks and how it was dealt with only after the 1st 3 warnings were given (when it became a criminal remit).

I wish to inform you that I have decided to part grant your request on 26th January, 2022.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

On receipt, your request was forwarded to the relevant Sections of An Garda Síochaná. They have advised us that the total fines issued within the DMR for the non-wearing of face coverings related to public transport vehicles within the requested timeframe was 20 (up to December 31st 2021) with a total amount paid of €320 as of 14th January 2022. Fines, which go unpaid within the required timeframe, are sent to the Courts Service for summons and a court date.

I am refusing the part of your request where you sought "Any additional information as regards the non wearing of face masks and how it was dealt with only after the 1st 3 warnings were given (when it became a criminal remit)" in accordance with Part 1(n) of Schedule 1of the FOI Act which is outlined above. The records that you seek pertain to the core functions of An Garda Síochána, that is, operational policing matters, as opposed to matters relating to human resources, or finance or procurement.

I am therefore refusing this part of your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000001-2022.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior

member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
