Dear

I refer to your request, dated and received on 4th January, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the terms of the Freedom of Information Act, I request the following information:

The numbers of sworn Garda members who have resigned, as opposed to retired, from January 1, 2018 to today, January 04, 2023.

I request the information in tabulated format by year and by rank. For example: 2019: 15 gardai, 12, sergeants, etc.

Also, I would like to know how many, by rank and year, were dismissed in the same timeframe.

I wish to inform you that I have decided to part-grant your request on the 11th January 2023.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochána to retrieve the information requested by you and a number of records have been identified.

I am to advise I am refusing to supply the records of the numbers of sworn Garda members who have resigned, as opposed to retired, from January 1, 2018 to 2021. Furthermore I am refusing to provide the records for dismissals for the same time period. I am doing so in accordance with Section 15 (1)(i)(i) of the FOI Act.
