# Re: Freedom of Information Request FOI-000019-2023 Request Part-Grant

#### Dear

I refer to your request, dated and received on 18<sup>th</sup> January, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

Under the FOI act 2014, I am seeking the following:

The number of applicants that were rejected by An Garda Síochána for being overweight or above personal weight requirements between the years of 2012 and 2023

The number of applicants that were rejected by An Garda Siochána for being unfit or below fitness requirements between the years of 2012 and 2023

I wish to inform you that I have decided to <u>part-grant</u> your request on 10<sup>th</sup> February, 2023. The purpose of this letter is to explain that decision.

#### 1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the relevant Sections of An Garda Síochána where searches for records where undertaken. I can advise that Garda recruits are required to complete a Physical Competency Test (PCT) in order to be accepted as a Garda trainee. Applicants are

not specifically rejected for being overweight. As such the records sought in part one of your request do not exist. Therefore, I must refuse your request for "The number of applicants that were rejected by An Garda Síochána for being overweight or above personal weight requirements between the years of 2012 and 2023" in accordance with Section 15(1)(a) of the FOI Act. Section 15(1)(a) states:

### Refusal on administrative grounds to grant FOI requests

15(1)(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

In respect of part two of your request, the table below details the number of applicants failing the PCT Test
