I refer to your request, dated and received on 31st January, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Will you supply me with the following information under the Freedom of information Act 2014

- 1) The amount that An Garda Siochana spent on purchasing no parking traffic cones in the years of 2020, 2021, 2022 and to-date in 2023 in tabular form
- 2) The name of the company that was awarded the contract to provide An Garda Siochana with no parking traffic cones
- 3) When is this current contract due to expire

I wish to inform you that I have decided to part-grant your request on the 21st February 2023.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Upon receipt, your request was forwarded to the Finance Section within An Garda Síochána and a number of records were found.

The table below outlines the amount that An Garda Síochána spent on purchasing no parking traffic cones in the years 2020, 2021, 2022 and to date in 2023 which addresses part 1 of your request.

In regards to Part 2 of your request I can confirm that the cones were purchased from JW Balfour.
