Dear

I refer to your request, dated and received on 1st March, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the FOI Act 2014, I am seeking the following:

- 1) The total number of sick days taken by all staff working for An Garda Siochana in 2020
- 2) the number of sick leave days that were taken with a medical certificate, and the total number of sick leave days which were uncertified in 2020
- 3) A breakdown of sick leave days taken by staff i.e. rank and file gardai / detectives/garda sergeants and the number of days taken by administrative and other staff employed by An Garda Siochana.
- 4) A breakdown if possible of leave as it related to a/ Covid-19 infection, b/ Covid-19 close contact, c/ all other illnesses.

I wish to inform you that I have decided to part-grant your request on the 16th March 2021.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt your request it was forwarded to the relevant Sections of An Garda Síochaná who have provided records to this Office in response to your request.

I wish to advise you that I am granting your request for the records sought in parts 1 and 3 of your request. Please see tables below.

I am refusing the release of records in respect of parts 2 and 4 of your request and am doing so of in accordance under Section 15(1)(a) which states:

Refusal on administrative grounds to grant FOI requests

15(1)(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

As regards to part 2 of your request this office has been advised that the inputting of certified and uncertified sick leave may not be captured accurately on the Sick Absences Management System (SAMS) therefore to provide sick leave broken down may result in an inaccurate calculation of the different classifications of sick leave.

I have further been advised that the Sick Absences Management System (SAMS) does not record COVID absences as sick leave. In line with other public sector bodies, COVID related absences are recorded as special leave. However, there are several circumstances under which special leave with pay can be granted and the Garda Employee Management System (GEMS) does not differentiate between those reasons. Therefore it is not possible to provide specific data on COVID related absences for members, as GEMS does not have a specific category for COVID related absences. In order to establish details of COVID related absences a trawl through all special leave absences would have to be conducted.

As a result of the COVID-19 pandemic, An Garda Síochána has initiated a number of measures to protect Garda Members and Staff. Included in these measures are:

- o Changes to the roster for Garda Members,
- o Increased signage in stations and the provision of hand sanitizing facilities,
- The use of PPE including face masks in situations where Members are unable to maintain recommended social distancing,
- o The use of remote working where this can be facilitated.

As frontline responders, Members of An Garda Síochána are at increased risk of exposure to COVID-19 on a daily basis. However, it should be noted that Garda Members have maintained significantly high rates of availability during the pandemic and have responded to this emergency in order to continue serving our communities and protect the State by continuing to deliver a functioning police and security.

2. Right of Appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
