#### Dear

I refer to your request, dated and received on 24<sup>th</sup> March, 2021 and further clarified by telephone on 26<sup>th</sup> March, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom of Information Act 2014, I wish to obtain a copy of recordings detailing:

- (a) The number of sexual misconduct complaints made against members of An Garda Síochána, broken down by year, between the years of 2010 to 2020.
- (b) The number of sexual misconduct complaints made against members of An Garda Síochána which were upheld, broken down by year, between the years of 2010 to 2020.

Clarified Request:

The number of sexual misconduct complaints made against members of An Garda Siochána made by other members of An Garda Siochána, broken down by year, between the years of 2010 to 2020.

I wish to inform you that I have decided to grant your request on 8th April, 2021.

The purpose of this letter is to explain that decision.

#### 1. Findings, particulars and reasons for decision
