### Re: Freedom of Information Request FOI-000133-2021 Request Granted

#### Dear

I refer to your request, dated 31<sup>st</sup> March, 2021 and received on 1<sup>st</sup> April, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

Under the FOI Act 2014, I am seeking the following:

- a record detailing the number of gardaí currently suspended broken down by the length they have been suspended for e.g. 0-2 years, 2-4 years, 4-6 years, 6-8 years, 8-10 years, 10 years +
- a record detailing the number of gardai that have been sacked/dismissed in each of the following years 2018, 2019, 2020.
- a record detailing the number of probationer gardaí who have not been deemed suitable for attestment to full membership of AGS in each of the following years 2018, 2019, 2020.

I would prefer to receive this information electronically, ideally in its original electronic format.

I wish to inform you that I have decided to grant your request on the 23rd April 2021.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision.

Upon receipt of your request, the relevant sections of An Garda Síochána were contacted to retrieve the information requested by you and a number of records have been identified.

Part 1 of your request is seeking a record detailing the number of gardaí currently suspended broken down by the length they have been suspended for.

Table A below sets out the number of suspensions of Garda and the duration.

Table A: - Number of Members Suspended - Duration

The numbers who are currently suspended 10 years and over	Nil
The numbers who are currently suspended 8 - 10 years	1
The numbers who are currently suspended 6 - 8 years	1
The numbers who are currently suspended 4 - 6 years	2
The numbers who are currently suspended 2 - 4 years	15
The numbers who are currently suspended 2 years and less	52

These figures are correct as of 1st April 2021.

Parts 2 and 3 of your request are seeking "a record detailing the number of gardai that have been sacked/dismissed in each of the following years 2018, 2019, 2020" and a record detailing the number of probationer gardaí who have not been deemed suitable for attestment to full membership of AGS in each of the following years 2018, 2019, 2020.

In 2018 2 Members were dismissed, in 2019 12 Members were dismissed and in 2020 3 Members were dismissed. These figures are inclusive of 4 probationer Gardai dismissed in 2019 and 3 probationer Gardai dismissed in 2020.
