I refer to your request, dated and received on 15th April, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

In accordance with Section 12 of the Freedom of Information Act, I request access to records which are non-personal and which I believe are held by An Garda Siochana.

I request the following records relating to finance within An Garda Siochana:

The amount of money that has been taken in by An Garda Siochana in Co. Clare as a result of speeding fines in the years 2016, 2017, 2018, 2019, 2020 and 2021, up to and including the date of this request.

I wish to inform you that I have decided to part-grant your request on 20th April, 2021.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to the relevant sections of An Garda Síochána who conducted a search for records containing the information you have requested.

Please see attached Appendix which details the number and amount of fines paid offences from the 1st January to 31st March, 2021. The figures were extracted based on the date the payments were processed by An Post. Therefore, some payments may relate to offences that occurred in the later stages of the previous years.

The Sections of the Freedom of Information Act 2014 that deny access to information are known as exemptions. In this regard, I am also refusing to provide records with regard to the years 2016, 2017, 2018, 2019 and 2020 in accordance with section 15 (1)(i)(i) of the Freedom of Information Act 2014 as these records were previously sought in previous Freedom of Information requests.

 - (i) the request relates to records already released, either to the same or a previous requester where
 - (i) the records are available to the requestor concerned
