#### Dear

I refer to your request, dated and received on 5<sup>th</sup> May, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

- 1) The top 12 most language interpreters that An Garda Siochana have used to assist them with suspects or victims of crime who have very little or English in the years of 2021 and to-date in 2022 in tabular form
- 2) The amount An Garda Siochana have spent on hiring foreign language interpreters in the years of 2021 and to-date in 2022 in tabular form
- 3) The name of the company that was awarded the contract to provide AGS with interpreters services upon request
- 4) When the current contract for the provision of interpreters services to AGS is due to expire

I wish to inform you that I have decided to grant your request on the 20th May 2022.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the Finance Section of An Garda Síochána who conducted a search for records relating to your request. The table below sets out the records
