I refer to your request, dated 24<sup>th</sup> May, 2022 further clarified and received on 25<sup>th</sup> May, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

1) The number of Gardai that attended each training course either held in Garda Headquarters or Garda Training College, Templemore in the years of 2019, 2020, 2021 and to-date in 2022. Please include the duration of each course in tabular form.

To be further assistant what I am seeking eg In 2019 7 standard motorcycles courses were held in Garda Headquarters and 105 Gardai attended and each course was 5 days duration etc

#### Clarified Request:

Thanks for your email for additional information. I will narrow down my request to seek the number of Gardai who attended each level of public order training and each level of car/van and motorcycle training courses that were held either in Garda HO or

Garda Training Centre in the years of 2021 and to-date in 2022. Also please include the duration of each of these courses in tabular form.

I wish to inform you that I have decided to grant your request on the 13th June, 2022.
