I refer to your request, dated 1st June, 2022 and received on 2nd June, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to make a request under the FOI act for the total number of members in the Mayo Division on June 1st 2022 with a breakdown of members in Mayo's five divisions, the Ballina area, the Castlebar district, the Westport district, the Claremorris/ Swinford district, the Belmullet district and individual stations and a breakdown of Gardai, Sergeant Gardai, inspectors, superintendents and chief superintendents and details on the members who have been newly attested to the Mayo division from Templemore, transferred to county Mayo, transferred out of the Mayo division, retirees and deaths between June 1st, 2021 and June 1st, 2022 and comparative figures of the members in the Mayo division -including a breakdown of ranks and the numbers in each of the five areas and individual stations -on June 1st, 2019, June 1st, 2020 and June 1st, 2021. If you could provide me with these details and figures I'd be very grateful and if you have any questions or you need any further clarification, please do not hesitate to contact me. Many thanks.

I wish to inform you that I have decided to grant your request on the 17th June 2022.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochaná where searches where conducted in respect of same and a number of records were located.

The attached Appendix shows the personnel strength of An Garda Síochána in the Mayo Division broken down by rank as at 31st May 2019 to 31st May 2022.

I can advise that for the time period June 2021 to June 2022, there was 1 newly attested member to the Mayo Division, 9 members transferred into the Division and 15 members transferred out. I can confirm that there were no deaths in service and 8 Garda members retired in the Mayo Division for the same period.

2. Right of Appeal
