I refer to your request, dated and received on 29th June, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom of Information Act 2014, I request the following:

- a. The number of Garda Siochána stations in which adequate and functioning electronic recording equipment that has not been provided with and installed for the purpose of recording interviews under the Criminal Justice Act, 1984 (Electronic Recording Of Interviews) Regulations, 1997 Regulations;
- b. The amount spent by An Garda Síochána on electronic recording equipment for the purpose of recording interviews under the 1997 Regulations in 2022, 2021, 2020, 2019, 2018, 2017, 2016 and 2015;
- c. The amount spent by An Garda Siochána on training for members in each of the years 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022 on the usage of electronic recording equipment for the purpose of recording interviews.

I wish to inform you that I have decided to part-grant your request on the 20th July, 2022.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Details of your request were forwarded to the relevant sections of An Garda Síochána where searches were conducted in respect of same.

As previously outlined above, Part 1 (n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. The records sought in the first part of your request relate to operational policing and do not constitute an administrative record relating to human resources, finance or procurement. I am therefore refusing Part A of your request as this information falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

The second part of your request sought "The amount spent by An Garda Siochána on electronic recording equipment for the purpose of recording interviews under the 1997 Regulations in 2022, 2021, 2020, 2019, 2018, 2017, 2016 and 2015". The table below provide the details requested.
