I refer to your request, dated and received on 10th August, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I was wondering if you could tell me the following details under the Freedom of information $Act\ 2014$

- 1) The total amount that An Garda Siochana has spent on external veterinary services for the animals in both the Garda Mounted Unit and the Garda Dog Unit in the years of 2019, 2020 and to-date in 2021 in tabular form
- 2) The amount An Garda Siochana have paid each external vets for external veterinary services for either Garda Mounted Unit or Garda Dog Unit in each of the years in question in tabular form
- 3) When the current contract to provide external veterinary services to the Garda Mounted Unit and Garda Dog Unit will expire

I wish to inform you that I have decided to part-grant your request on the 2nd September 2021.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to the relevant sections within An Garda Síochána who conducted a search for records containing the information you requested.
