## Re: Freedom of Information Request FOI-000351-2022 Request Granted

#### Dear

I refer to your request, dated and received on **22nd September**, **2022** which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

### Your request sought:

Records of the amount of money paid to individuals/firms in 2021 and for the first six months of this year for media training and PR services, and the number of Gardaí to receive media training in 2021 and the first six months of this year and their rank.

Records of the number of PR firms who applied for the tender in 2021 and this year and how much the tender in each year was estimated to cost

I wish to inform you that I have decided to grant your request on 14th October, 2022.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision

On receipt your request was forwarded to the relevant Sections of An Garda Síochaná who have in turn provided this office with records.

I can advise that the amount paid to the Communications Clinic in 2021 and 2022 for public relations services, and communications support was €242,040. In addition I wish to advise that between 2021 and 2022 there were 8 courses provided for 17 members at a cost of €7,150. The training was provided to members of Assistant Commissioner, Chief Superintendent and Superintendent ranks.

PR services refers to support for internal communications initiatives to ensure all Garda personnel are kept regularly informed of COVID-19 health and safety measures, mental health and wellbeing supports, and changes to public health guidelines and regulations and operating procedures to keep themselves and the public safe during this national health crisis

In relation to the second part of your request I can advise that 3 companies applied for the tender in 2020. The contract was awarded in July 2020 for one year with the option to extend by 2 years. There has been no request for tender (RFT) published since 2020. The tender was estimated to cost €32,750 per year.

### 2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
