## Re: Freedom of Information Request FOI-000422-2018 Request Refused

*Dear Mr*

I refer to your request, dated and received on 17<sup>th</sup> October, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- *I wish to apply for the following under the terms of the Freedom of Information Act: please provide information as to the number of times in the first nine months of this year (2018) when a homeless family, or a homeless person, has been accommodated at a Garda station. Please, where possible, provide details as to the size of the family in question, any occasions where they stayed at a Garda station for a number of nights consecutively or were repeat visitors. Please provide copies of any correspondence between an Garda Síochána - either at national or local/regional/station level - with the relevant housing bodies (local authority/DRHE/Emergency placement line etc) in that period with regard to families that have come to the attention of gardai in this way in that period. Please provide any details for the same nine month period as to the number of referrals made by Gardai to Tusla with regard to families living in emergency accommodation/who are homeless. Finally, please provide information as to any rise or fall in the number of these referrals in this six month period compared with any comparable data for previous six monthly periods.*

I wish to inform you that I have decided to refuse your request on 19<sup>th</sup> October, 2018.

The purpose of this letter is to explain my decision.

## **1. Findings, particulars and reasons for decision**

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

## **2. Right of Appeal**

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **FOI-000422-2018**.

The making of a late appeal may be permitted in appropriate circumstances.
