## Re: Freedom of Information Request FOI-000440-2020 Request Part Grant

#### Dear .

I refer to your request, dated and received on 24th November, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

I am seeking the following under the Freedom of Information Act -

- 1. The top 15 monetary sanctions imposed on Gardai to be found in breach of Garda discipline in 2020 and the nature of the breach of discipline in each case.
- 2. The number of Gardai to be suspended from duty in 2020 and the reason for the suspension in each case.
- 3. The number of Gardai to be found to be in breach of Garda discipline in 2020 and the total amount imposed in fines this year.
- 4. The number of Gardai to be dismissed from the force this year and the reason in each case.

I wish to inform you that I have decided to part grant your request on the 21st December, 2020. I have numbered your request for ease of reference.

The purpose of this letter is to explain my decision.

### 1. Findings, particulars and reasons for decision.

The Internal Affairs Section of An Garda Síochána were contacted to identify the information requested in your FOI Request. The tables below were provided by the aforementioned Section, these tables detail the information requested in part 1 and 2 of your request.
