Dear

I refer to your request, dated and received on 7th March, 2017 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to know what is the yearly allowance for each Garda to buy uniforms. If all uniforms are provided free of charge, could you please specify what kind of clothing items each Garda receives?.

Is cost of washing being refunded or are uniforms washed by dry cleaners and paid by Garda Office.

I wish to inform you that I have decided to <u>partially grant</u> your request on the 31st March, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions.

On receipt of your request, the Finance Section of An Garda Síochána conducted searches to identify records relevant to your request.

Therefore, I am refusing the first part of your request seeking "the yearly allowance for each Garda to buy uniforms" pursuant to section 15(1)(d) of the FOI Act which states:

Refusal on administrative grounds to grant FOI requests.

15. (1) A head to whom an FOI request is made may refuse to grant the request where—

(d) the information is already in the public domain

With regard to the parts of your request regarding the issuing and maintenance of uniforms I advise that uniforms are provided through a central purchasing section and are not paid for by gardaí and sergeants. A member of Inspector rank and above is obliged to purchase his/her uniform.

The Garda uniform incorporates elements of personal protectection equipment (PPE) which are appropriate for the duties being performed. Certain types of duty require specific PPE elements to be included in the uniforms such as motorcycle and air support duties.

On entering the Garda College a student is provided with a standard uniform which consists of the following items:

- Hat
- Tie
- Fleece

- Hat Cover
- Tie Pin
- Epaulettes
- Trousers
- Shirt
- Belt
- T -Shirts
- Shoes
- Waterproof navy Jacket
- High Visibility waterproof Jacket
- High Visibility light weight jacket

Each member of the is required to maintain an operational and a formal uniform. It is a disciplinary offence not to comply with An Garda Siochána's dress code or to be untidy in uniform.

Members are paid a taxable uniform allowance for maintenance and upkeep which varies in amount depending on the rank of the member and the type of uniform to be made.

2. Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000099-2017.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
