RE: Freedom of Information Request FOI-000201-2017 **Request Refused**

Dear Ms. Bracken,

I refer to your request, dated and received on the 8th May 2017, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered

Your request sought:

How much has been spent on media and public relations training for Garda commissioner Noirin O'Sullivan, inclusive of any Communications Clinic fees and any and all other specific media and PR training for Ms O'Sullivan, since the beginning of this year.

I wish to inform you that I have decided to refuse your request on the 31st May, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

A search of the financial management system was conducted at Finance Section, Garda Headquarters to identify the companies that were paid from the Garda Vote relating to public relations and media training services.

I advise that the expenditure on media and communication training by An Garda Síochána have been the subject of a number of requests under the FOI Act. An Garda Síochána, in keeping with section 8 of the FOI Act, maintains a list of decisions made on all non-personal requests, including the full decision letter on the Garda website (www.garda.ie), in the Freedom of Information section.

I advise that I am refusing your request for “*How much has been spent on media and public relations training for Garda Commissioner Noirin O'Sullivan, inclusive of any Communications Clinic fees and any and all other specific media and PR training for Ms O'Sullivan, since the beginning of this year.*” pursuant to section 15(1)(a) of the FOI Act, which states:

Refusal on administrative grounds to grant FOI requests

15. (1) A head to whom an FOI request is made may refuse to grant the request where
(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

However, I advise that the following ranks were involved in media training in 2017: Assistant Commissioner; Civilian Professional; Assistant Principal, Superintendent; Inspector; Sergeant and Garda.

2. Right of Appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
