## Re: Freedom of Information Request FOI-000009-2018 Request Refused

*Dear*

I refer to your request, dated and received on 4<sup>th</sup> January, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “insofar as it relates to administrative records relating to human resources, or finance or procurement matters”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- *The number of rape kits, aka Early Evidence Kits and Sexual Offences Examination Kits, collected and booked into evidence from the period of January 1, 2007 through the date of this request (or the closest range of years otherwise available).*
- *The number of kits that have been processed by a public or private crime or forensic laboratory or equivalent processing location from the period of January 1, 2007 through the date of this request (or the years otherwise available).*
- *The number of unprocessed kits in any storage facilities currently under the jurisdiction and control of An Garda Síochána, including those held by medical personnel or at external laboratory locations.*
- *Any data regarding the status or ultimate disposition of cases in which a kit was collected. Please include all available segregable data.*

I wish to inform you that I have decided to refuse your request on the 4<sup>th</sup> January, 2018.

The purpose of this letter is to explain my decision.

## **1. Findings, particulars and reasons for decision**

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term “administrative records” is understood to mean records relating to the processes of running and managing a business or organisation. As a result the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

The records that you sought relate to operational policing matters carried out by An Garda Síochána, as opposed to administrative matters relating to human resources, or finance or procurement.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

## **2. Right of Appeal**


