# Re: Freedom of Information Request FOI-000516-2017 Request Refused

#### Dear

I refer to your request, dated and received on 17<sup>th</sup> November, 2017 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

### Your request sought:

- The number of gardai who are assigned to Divisional Burglary Response Units (BRU) for the first quarter, second quarter, third quarter and final quarter for the years 2015, 2016, and year ending 17/11/2017.
- -The figure should be broken down by garda division. the rank of gardai assigned to the BRU and broken down on a quarterly annual basis.

I wish to inform you that I have decided to refuse your request on the 21st November, 2017.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation. As a result, the FOI Act excludes operational policing business as opposed to the defined administrative processes of An Garda Síochána.

An Garda Síochána have specific functions under section 7 of the Garda Síochána Act 2005 and hold a unique position within Irish Society. Under section 7 of the Garda Síochána Act 2005 the primary function of An Garda Síochána is to provide policing and security services for the State. This is a unique function attributed to An Garda Síochána with the objective of:

- (a) preserving peace and public order,
- (b) protecting life and property,
- (c) vindicating the human rights of each individual,
- (d) protecting the security of the State,
- (e) preventing crime,
- (f) bringing criminals to justice, including by detecting and investigating crime, and
- (g) regulating and controlling road traffic and improving road safety.

The functions that are carried out in the process of applying the above mention objectives and primary function using numerous pieces of legislation does not meet the threshold of an Administrative Record. Operational activities, application of legislation, investigations and oversight processes are not an administrative record for the purposes of Human Resources, Finance or Procurement as set out at Part 1(n) of Schedule 1 of the FOI Act.

The records that you sought in your request relate to operational policing matters carried out by An Garda Síochána, as opposed to administrative matters relating to human resources, or finance or procurement.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as the records do not meet the criteria of administrative records as defined in the Act.

#### 2. Right of Appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
