Re: Revised Rate of Overnight Subsistence Allowance for Members of An Garda Síochána, Effective from 1 January 2024.

This HQ Directive sets out revised rates for the overnight subsistence allowance **only**, with effect from 1st January 2024.

This increase has been sanctioned by the Department of Public Expenditure National Development Plan Delivery and Reform, subject to a review of the Travel and Subsistence Scheme in An Garda Síochána being undertaken in early course.

All other subsistence rates remain unchanged as per HQ Directive 33/2009 and 34/2009.

Rates of Overnight Subsistence Allowance payable to members of An Garda Síochána with effect from 1 January 2024.
