## Re: Freedom of Information Request FOI-000122-2024 Request Granted

*Dear*

I refer to your request, dated **29<sup>th</sup> March, 2024** and received on **2<sup>nd</sup> April, 2024** which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- *a record/database/spreadsheet of the number of days lost to illness by garda staff in 2023 in the following categories: flu/viral, mental health, musculoskeletal, not provided, other-please specify, post pregnancy, pregnancy related, surgery/post op, injury on duty: accident, injury on duty: RTA, malicious injury off duty, malicious injury on duty, occupational illness arising from duty, critical illness.*
- *a record/database/spreadsheet of the number of days lost to illness by garda staff in total for 2023.*

I wish to inform you that I have decided to grant your request on the 11<sup>th</sup> April 2024. The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána to retrieve the information requested by you.
